3 **Ordinance amending the Administrative Code to transfer administration of the Mayor's**
4 **Fund for the Homeless from the director of the Human Services Agency to the director**
5 **of the Mayor's Office of Housing Opportunities, Partnerships and Engagement (HOPE).**

13 Be it ordained by the People of the City and County of San Francisco:

14 Section 1. The Administrative Code is hereby amended by revising Section 10.100-
15 106 to read as follows:

16 **SEC. 10.100-106. MAYOR'S FUND FOR THE HOMELESS.**

17 (a) **Establishment of Fund.** The Mayor's Fund for the Homeless is established as a
18 category six fund to receive all donations which may from time to time be received by the
19 City and County of San Francisco for providing shelter, food and other assistance for the
20 homeless.

21 (b) **Use of the Fund.** The fund is to be used exclusively for the purpose of providing
22 food, shelter and supportive services to the homeless and for costs incurred for promotion of
23 the fund. Funds which are donated for a specific project for the homeless shall be expended
24 only for that project.

25 (c) **Administration of Fund.** The director of the ~~Human Services Agency~~ Mayor's Office

1 of Housing Opportunities, Partnerships and Engagement (HOPE), or his designee, is authorized to
2 administer the Mayor's Fund for the Homeless and to determine expenditures from the fund,
3 in keeping with the original intended uses of the fund. The director or his designee shall
4 report regularly to the ~~Human Services Commission~~ City's Local Homeless Coordinating Board on
5 gifts to and expenditures from the fund, ~~at such time as all expenditures from the department's gifts~~
6 ~~fund are reported upon.~~

7
8 Section 2. Effective Date. This ordinance shall become effective 30 days after
9 enactment. Enactment occurs when the Mayor signs the ordinance, the Mayor returns the
10 ordinance unsigned or does not sign the ordinance within ten days of receiving it, or the Board
11 of Supervisors overrides the Mayor's veto of the ordinance.

12
13 Section 3. Scope of Ordinance. In enacting this ordinance, the Board of Supervisors
14 intends to amend only those words, phrases, paragraphs, subsections, sections, articles,
15 numbers, punctuation marks, charts, diagrams, or any other constituent parts of the Municipal
16 Code that are explicitly shown in this ordinance as additions, deletions, Board amendment
17 additions, and Board amendment deletions in accordance with the "Note" that appears under
18 the official title of the ordinance.
