

1 [Extending Time for Negotiations]

2 **Motion extending time for negotiations pursuant to Charter Section 11.100.**

3
4 WHEREAS, The City and fourteen of its labor unions have existing collective
5 bargaining agreements that are effective through June 30, 2009;

6 WHEREAS, The City will be meeting and conferring with these labor organizations over
7 successor collective bargaining agreements for fiscal year 2009-2010 in accordance with
8 Charter section A8.409; and

9 WHEREAS, In order to be included in the budget to take effect July 1, 2009, an
10 agreement or arbitration award must be approved and implemented by ordinance within the
11 timelines set forth in Charter Section A8.409-4, as may be extended by Charter Section
12 11.100; and

13 WHEREAS, The Board of Supervisors previously clarified such deadlines in Resolution
14 No. 91-97; and

15 WHEREAS, Under Charter Section A8.409-4 the Human Resources Director has
16 requested that the Board of Supervisors take action pursuant to Charter Section 11.100 to
17 extend by thirty days the date for final adoption of ordinances approving and implementing
18 successor collective bargaining agreements; now therefore, be it

19 MOVED, That the date for final adoption of ordinances approving and implementing
20 successor collective bargaining agreements to be effective July 1, 2009 is hereby extended by
21 thirty days. For unions in negotiations for which impasse has not been declared and for
22 unrepresented employees, the date for final adoption of ordinances approving and
23 implementing successor collective bargaining agreements to be effective July 1, 2009 is June
24 16, 2009. Such proposed collective bargaining agreements and the unrepresented

1 employees ordinance must be submitted to the Clerk of the Board on or about May 5, 2009 in
2 a form that will allow for complete review and costing in time for final adoption by June 16,
3 2009; and be it

4 FURTHER MOVED, That Arbitration panel awards and mediated settlements issued
5 pursuant to Charter Section A8.409-4 should be submitted to the Clerk of the Board in a form
6 that will allow for complete review and costing in time for final adoption by June 30, 2009.
