Program Manager-Child Care Policy and Planning

San Francisco Department of Human Services – Human Service Agency

Michele Rutherford has worked in the field of Human Services since 1979 in both the private and public sector. Ms. Rutherford received a B.A. from Olivet College in 1977 and a Master of Social Work degree in Policy, Planning, and Administration from Western Michigan University in 1983. She has worked as a public school teacher and a community planner, designing and implementing new programs for over 30 years.

Beginning in 1984 Ms. Rutherford worked for three years as a child welfare worker for San Francisco County Department of Human Services. Subsequently she worked as a trainer, as a Management Assistant in Budgeting, then as a Manager in child welfare from 1990 to 1997, overseeing all aspects of the program from Emergency Response to Adoptions, Licensing to Contracting.

With the advent of welfare reform, in 1997 Ms. Rutherford was appointed to plan and manage child care programs for the Department and the city. In her new role Ms. Rutherford administered increased child care subsidies, child care capacity initiatives and supportive services. These services include model subsidy administration, subsidy programs for homeless and at-risk children, and the development of mildly ill care and emergency back-up care for CalWORKs families.

Ms. Rutherford has been instrumental in the design and redesign of numerous San Francisco programs supporting families and their children. Other innovative child care system supports designed and implemented under Ms. Rutherford include Gateway for Quality – Quality Assessment system, the Child Care Inclusion Project, and San Francisco's model Child Care Facilities Fund, which supports facilities improvement and expansion for licensed child care centers and family child care homes, as well as the city's Section 108 Loan Program. (This is a program in which child care facilities loans are subsidized up to 80% by the Department of Human Services – Human Service Agency.) These programs have improved quality and increased the number of licensed slots in San Francisco by over 1000 over a three-year period. Start-up grants for infant/toddler centers have also been a key resource for capacity expansion initiated by Ms. Rutherford.

Ms. Rutherford also implemented, in partnership with other city departments, child care mental health consultation and health consultation to licensed centers and family child care homes.

Under Ms. Rutherford's direction, San Francisco designed and implemented WAGES+, a \$4 million nationally recognized model wage and professional development initiative that augments the salaries of staff at licensed centers and family child care homes serving low-income children, bringing up entry-level salaries and augmenting staff wages based on longevity, responsibility, and adherence to professional development criteria.

Ms. Rutherford was an original founder of the Genesee County Food Bank, the San Francisco Worker's Children's Fund, and has served on the Board of Our Family Coalition.

Ms. Rutherford is a Commissioner of the San Francisco First 5 Commission and serves on the SF First 5 Program Committee. She currently chairs the San Francisco Child Care Planning and Advisory Councils' (CPAC) Needs Assessment Committee and co-chairs CPAC's Citywide Planning process. She represents HSA on the Afterschool for All Advisory Committee. Ms. Rutherford also serves as the Co-Chair of the County Welfare Directors Association (CWDA) statewide Child Care Committee. Finally, Ms. Rutherford serves as a parent representative on the Alvarado Elementary School Site Council and is an active volunteer

Ms. Rutherford has two sons, the youngest of which attends Alvarado elementary school where he participates in a wonderful afterschool program, making Ms. Rutherford a happy consumer of quality afterschool.

Michele Rutherford has worked in the field of Human Services since 1979 in both the private and public sector. Ms. Rutherford received a B.A. from Olivet College in 1977 and a Master of Social Work degree in Policy, Planning, and Administration from Western Michigan University in 1983.

Beginning in 1984 Ms. Rutherford worked for three years as a child welfare worker for San Francisco County Department of Human Services. Board Qualifications:

The Child Care Planning and Advisory Council consists of 25 members. The Board of Supervisors appoint 12 members, one each of whom is nominated by an individual member of the Board, and a second being nominated by the President of the Board.. The Board of Education or County Superintendent of Schools, if the Board of Education delegates the appointment power to her or him, shall appoint the remaining 12 members and the Board of Supervisors and the Board of Education, or County Superintendent of Schools, if the Board of Education delegates the appointment power to her or him, shall jointly appoint 1 member. The members appointed by the Board of Supervisors shall be representative of the following categories: A) Parents, guardians or caretakers with varied income levels who use child care and/or early education services, including but not limited to clients of publicly subsidized programs such as CalWORKS, and other child care programs funded through the San Francisco Human Services Agency, the California Department of Education, Head Start or Preschool for All B) Child Care Providers - Private and subsidized child care providers including, but not limited to, from a private center, from a family day care home, a Title 5 program, a school age program, from a Head Start center and from a Preschool for All site. C) Discretionary: representatives of the public at large and/or representatives from any of the other categories, or outside of these categories at the discretion of the appointing agencies D) Community representatives: Parent advisory councils of public and private child care programs; associations of child care providers, family child care providers and Head Start; City College of San

Francisco, San Francisco State University, public interest organizations including, but not limited to, the Child Care Law Center, Low Income Investment Fund community organizations, members of labor organizations and local businesses that fall within the definition of "community representative" as described in Subsection (d)(1) (B) and other community and public agency representatives that deal with child care. E)Public Agency Representatives: Representative from two of the following agencies - the Department of Children, Youth and their Families, Human Services Agency, San Francisco Children and Families Commission, Community Care Licensing, Department of Public Health, Recreation and Parks Department, Mayor's Office of Community Investment and San Francisco Housing Authority, or other entities.

The Council is established to advise the Board of Supervisors, the Mayor, the SF Children and Families Commission and, with their consent, the Board of Education and the Superintendent of Schools about child care issues. The Council will serve as a representative advisory and planning body to maintain, expand and improve local child care services. The Council will provide links between government and the community, and will work to maximize the amount and impact of local State, federal and private resources and funding for child care in San Francisco. Powers and Duties are outlined in Administrative Code section 5.200.

All terms shall be for three years. Members may serve for up to two consecutive terms, and may be re-appointed after one year off the Council. No terms served prior to March 8, 2010 shall be counted towards the term limit for Council members. A member appointed to serve a term of two years or less, including the initial term provided in the preceding paragraph, shall not be deemed to have served a full term for purposes of this term limit.

Compensation: Upon approval by the Council, each member who is not otherwise compensated to attend meetings may receive a stipend of no more than \$50 per meeting, not to exceed \$300 annually, exclusively from funds provided to the Council by the State of California.
