

1 [Establishing Monthly Contribution Amount]

2 ESTABLISHING MONTHLY CONTRIBUTION AMOUNT TO HEALTH SERVICE TRUST
3 FUND.

5 WHEREAS, Pursuant to Section A8.423 of Appendix A to the City Charter, the
6 Health Service Board (the "HS Board") is required to conduct a survey of the ten counties in
7 the State of California, other than the City and County of San Francisco, having the largest
8 populations to determine the average contribution made by each such county toward the
9 providing of health care plans, exclusive of dental or optical care, for each employee of such
10 county; and

11 WHEREAS, Pursuant to such Charter Section, the HS Board is required to
12 certify to the Board of Supervisors "the average contribution" (as such term is defined in such
13 Charter Section) as determined by such survey; and

14 WHEREAS, According to the California Department of Finance, Demographic
15 Research Unit, the ten most populous counties in the State of California other than San
16 Francisco (in descending order of population) are: Los Angeles, San Diego, Orange, Santa
17 Clara, San Bernardino, Riverside, Alameda, Sacramento, Contra Costa and Fresno
18 (collectively, the "Survey Counties"); and

19 WHEREAS, Under the survey of each of the Survey Counties which was
20 completed on January 7, 1999 (a copy of which is on file with the Clerk of the Board of
21 Supervisors in File No. 990606), the HS Board has determined that "the average
22 contribution" is the sum of One Hundred Eighty & Eighty-five dollars (\$180.85); and

1 WHEREAS, Pursuant to such survey, the HS Board has certified "the average
2 contribution" to the Board of Supervisors as required under Section A8.423 of Appendix A to
3 the City Charter;

4 now, therefore, be it

5 RESOLVED, That the certification by the HS Board of "the average amount" is
6 hereby accepted and shall constitute the monthly amount to be contributed to the Health
7 Service Trust Fund for Fiscal Year 1999-2000 pursuant to the Charter.
