3	Resolution proclaiming May 13 through 18, 2024, as the Annual National Stuttering
4	Awareness Week in the City and County San Francisco.

6	WHEREAS, Across the country, the second week of May is recognized as Stuttering
7	Awareness Week; and
8	WHEREAS, Stuttering is a speech disorder characterized by repetition of sounds,
9	syllables, or words, prolongation of sounds, and interruptions in speech; and
10	WHEREAS, Organizations dedicated to bringing hope and empowerment to children
11	and adults who stutter through support, education, and advocacy, have locations in San
12	Francisco; and
13	WHEREAS, Paul Castellano and Barbara Hubbard Koval, organized the drive to win
14	Congressional recognition for people who stutter, and in 1988 President Ronald Reagan
15	signed a proclamation establishing the second week in May 1988 as National Stuttering
16	Awareness; and
17	WHEREAS, Maya Chupkov of Proud Stutter organized the effort to win State
18	recognition for people who stutter, and in 2023 Speaker of the Assembly Robert Rivas signed
19	a proclamation establishing the second week in May 2023 as California's Stuttering
20	Awareness Week to encourage all Californians to support the stuttering community; and
21	WHEREAS, Many stutterers suffer frustration and embarrassment that can lead to
22	harmful emotional stress; and
23	WHEREAS, Stuttering is a form of speech diversity and should be recognized as
24	simply a different way of speaking; and

2	communicating with other people and stuttering may affect a person's quality of life,

4	WHEREAS, During Stuttering Awareness Week, Proud Stutter seeks to raise
5	awareness about communication disorders and the many ways that people with the daily
6	challenges of stuttering can be supported; and
7	WHEREAS, By recognizing these challenges, we can draw attention to the needs,
8	shine a light on these often invisible disabilities, and help avoid the negative consequences of
9	misunderstanding stuttering; and now, therefore, be it
