3 **Resolution determining that the transfer of a Type 48 on-sale general public**
4 **premises license from 975 Bryant Street to 46 Geary Street to Eric Chung for**
5 **Lounge 46 will serve the public convenience and necessity of the people of the**
6 **City and County of San Francisco, in accordance with Section 23958.4 of the**
7 **California Business and Professions Code, with conditions.**

9 WHEREAS, Eric Chung is seeking transfer of a Type 48 on-sale general public
10 premises license for Lounge 46 located at 46 Geary Street; and,

11 WHEREAS, The Planning Department has verified that the area is properly
12 zoned; and,

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the transfer of a Type 48
18 on-sale general public premises license from 975 Bryant Street to 46 Geary Street for
19 Eric Chung for Lounge 46, will serve the public convenience and necessity of the people
20 of the City and County of San Francisco.

21 Conditions: 1) The hours of operation shall not exceed 10:00 a.m. to 12 midnight
22 Sunday through Wednesday and 10:00 a.m. to 2:00 a.m. on Thursday, Friday and
23 Saturday. 2) No "happy hour" type of reduced price alcoholic beverage promotion shall
24 be allowed. 3) There shall be no coin operated games or video machines maintained
25 upon the premises at any time. 4) Entertainment provided shall not be audible beyond

1 the area under control of the licensee(s). 5) No person under the age of twenty-one (21
2 years of age) shall sell, furnish, or deliver alcoholic beverages. 6) Petitioner(s) shall not
3 permit its patrons or the general public to loiter or congregate on the sidewalks adjacent
4 to the licensed premises. The orderly standing of patrons in line to enter the premises
5 shall not be considered loitering or unlawfully congregating. 7) The sale of alcoholic
6 beverages for consumption off the premises is strictly prohibited. 8) The petitioner(s)
7 shall be responsible for maintaining free of litter the area adjacent to the premises over
8 which they have control. 9) At any time the premises are providing live entertainment,
9 the petitioner(s) shall provide security personnel that shall maintain order therein and
10 prevent any activity which would interfere with the quiet enjoyment of their property by
11 nearby residents. Said personnel shall be clothed in such a manner as to be readily
12 identifiable as security. 10) Petitioner(s) shall not make structural changes in the
13 premises interior without prior written approval from the Department. 11) The interior
14 lighting maintained therein shall be sufficient to make easily discernible the appearance
15 and conduct of all persons and patrons in that portion of the premises where alcoholic
16 beverages are sold, served, delivered or consumed. 12) The exterior of the premises
17 shall be equipped with lighting of sufficient power to illuminate and easily discernible the
18 appearance and conduct of all persons on or about the premises. Additionally, the
19 position of such lighting shall not disturb the normal privacy and use of any neighboring
20 residences. 13) At no time shall any person under the age of 21 years enter or remain
21 in this public premises.


