MOVED, That the Board of Supervisors of the City and County of San Francisco does hereby appoint the hereinafter designated persons to serve as members of the Sunshine Ordinance Task Force, pursuant to the provisions of Administrative Code, Section 67.30, for the terms specified:

Pixie (Rishi) Chopra (residency requirement waived), seat 4, succeeding Suzanne Manneh, term expired, must be appointed from names submitted by the New California Media and be a journalist from a racial/ethnic-minority-owned news organization, for the unexpired portion of a two-year term ending April 27, 2015.

Fiona Hinze, seat 11, succeeding Bruce Oka, term expired, must be a member of the public who has demonstrated interest in or has experience in this issues of citizen access and participation in local government, for the unexpired portion of a two-year term ending April 27, 2015.

FURTHER MOVED, That the Board of Supervisors makes the following findings:

- 1. The membership of the Sunshine Ordinance Task Force has a goal to be representative of the diversity of the City and County of San Francisco.
- 2. Applicant Pixie (Rishi) Chopra, new appointment, who is not a resident of San Francisco, is a person with experience that uniquely qualifies him to serve on the Sunshine Ordinance Task Force.
- 3. The Sunshine Ordinance Task Force has attempted to fill the position, for which Pixie (Rishi) Chopra was nominated, with an individual who is a City resident and

who has the specific experience, skills, and qualifications, but have been unable to do so at this time. The Rules Committee has certified that Pixie (Rishi) Chopra is qualified to serve on the Sunshine Ordinance Task Force.

4. After exercising due diligence, the Board of Supervisors concludes that there is no other possible representative, who is a resident of San Francisco and who has the specific experience, skills, or qualifications possessed by this applicant, and who is willing to serve on the Sunshine Ordinance Task Force at this time; and, be it

FURTHER MOVED, That the Board of Supervisors waives the residency requirement for Pixie (Rishi) Chopra, as allowed in cases where no qualified City resident, willing to serve, can be found, pursuant to Charter, Section 4.101, that requires person(s) appointed to boards, commissions, and advisory bodies established by legislative act of the Board of Supervisors to be resident(s) of the City and County of San Francisco.
