3 **Resolution determining that the issuance of a Type 40 (on-sale beer) alcoholic**
4 **beverage license to Joel Martinez, for The Comedy Station located at 244 Taylor**
5 **Street, will serve the public convenience and necessity of the people of the City**
6 **and County of San Francisco, in accordance with Section 23958.4 of the**
7 **California Business and Professions Code, with conditions.**

9 WHEREAS, Joel Martinez is seeking issuance of a Type 40 (on-sale beer)
10 alcohol beverage license for The Comedy Store, located at 244 Taylor Street; and,

11 WHEREAS, The Planning Department has verified that the area is properly
12 zoned; and

13 WHEREAS, The Police Department recommends that the liquor license
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business
16 and Professions Code, the Board of Supervisors of the City and County of San
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 40
18 (on-sale beer) alcoholic beverage license, to Joel Martinez for The Comedy Store,
19 located at 244 Taylor Street will serve the public convenience and necessity of the
20 people of the City and County of San Francisco.

21 Conditions: (1) Sales, service or consumption of alcoholic beverages shall be
22 permitted only between the hours of 10:00 a.m. and 12:00 a.m. (midnight) each day of
23 the week. (2) The sale of alcoholic beverages for consumption off the premises is
24 strictly prohibited. (3) Petitioner(s) shall not permit nude or topless entertainment, or
25 lingerie type shows. (4) The premises shall operate as a comedy club, with the sales of

1 alcoholic beverages as an incidental part of the operation. The premises shall be used
2 for no other purposes. (5) Sales and service of alcoholic beverages shall be permitted
3 only when the business is operating as a comedy club. (6) Petitioner shall not maintain
4 or construct any type of enclosed room(s) intended for use by patrons or customers for
5 any purpose. (7) No noise shall be audible beyond the area under control of the
6 licensee. (8) Petitioners shall not permit their patrons or the general public to loiter or
7 congregate on the sidewalks adjacent to the licensed premises. (9) The petitioner shall
8 be responsible for maintaining free of litter the area adjacent to the premises over which
9 they have control. (10) No pool or billiard table may be maintained on the premises. (11)
10 There shall be no coin operated games or video machines maintained upon the
11 premises at any time.




