3 **Resolution designating certain intersections as "STOP" intersections.**

5 RESOLVED, That, pursuant to the provisions of the California Vehicle Code, the
6 following intersections are hereby designated as "STOP" intersections, and the
7 Department of Parking and Traffic is hereby authorized and directed to cause "STOP"
8 signs to be installed thereat as designated below:

9 **STOP SIGNS - ESTABLISH**

Moraga Street, stopping 32nd and 34th Avenues at Moraga Street, making these
11 intersections all-way STOP's;

Broderick and Eddy Streets, stopping Eddy Street, making this intersection an
13 all-way STOP;

14

Carroll Avenue and Quint Street, stopping Carroll Avenue, making this
15 intersection an all-way STOP;

16

26th Avenue and Santiago Street, stopping 26th Avenue, making this intersection
17 an all-way STOP;

18

35th Avenue at Ulloa Street, stopping 35th Avenue at Ulloa Street, making this
19 intersection an all-way STOP;

20

Jerrold Avenue and Mendell Street, stopping Mendell Street, making this
21 T-intersection an all-way STOP;

22

Filbert Street, westbound, at Hyde Street, stopping westbound Filbert Street at
23 Hyde Street;

24

Merritt and Danvers Streets, northeast corner, stopping westbound Merritt Street
25 (stops the stem of this uncontrolled T-intersection); and,

26

Corbett Avenue and Danvers Street, southeast corner, stopping northbound
Danvers Street (stops the stem of this uncontrolled T-intersection).


