RESOLVED,

Recitals. All of the recitals herein are true and correct. Section 1.

Improvements Complete. That the work of improvement, as set forth and Section 2. described in the resolution of intention for these proceedings, Resolution 589-95 of the Board, have been completed to the satisfaction of this legislative body, and all payment has either been made or set aside for all existing or potential claims, costs and expenses.

Disbursement of Surplus. That all surplus monies, at this time remaining Section 3. in the Improvement Fund, shall be used to call bonds, thereby reducing outstanding assessments and subsequent assessment installments.
