2 **REQUIRING ALL CITY DEPARTMENTS AS STIPULATED IN CHAPTER 12D.A.6.A(1) AND**  
3 **12D.A.18 ( C ) OF SAN FRANCISCO'S ADMINISTRATIVE CODE TO SUBMIT A**  
4 **COMPREHENSIVE STRATEGIC PLAN DETAILING ALLOCATION OF RESOURCES**  
5 **RELATED TO THE IMPLEMENTATION OF THE DIVERSITY TRACKING SYSTEM, AN**  
6 **ACCOMPANYING BUDGET ITEMIZING THE FUNDS REQUIRED AS WELL AS A LIST OF**  
7 **ASSIGNED STAFF.**

8 WHEREAS, Chapter 12D.A.6.A(1) of the San Francisco Administrative Code requires  
9 the Director of the Human Rights Commission to issue annual and quarterly reports to the  
10 Board of Supervisors analyzing the City's progress in eradicating discrimination in City  
11 contracting, and to include in such reports recommendations for improving the City's efforts to  
12 eradicate aforementioned types of discrimination as well as abuses in the City's MBE/WBE  
13 programs; and

14 WHEREAS, Chapter 12D.A.18 ( C ) of the Administrative Code provides that the Board  
15 of Supervisors shall act upon the Commission's recommendations by the third Board meeting  
16 of May in each fiscal year subject to the Ordinance; and

17 WHEREAS, It is critical for City departments to play an integral and proactive role in the  
18 implementation of Chapter 12D through comprehensive input and participation in the Citywide  
19 Diversity Tracking System; now, therefore, be it

20 **RESOLVED**, That the Board of Supervisors of the City and County of San Francisco  
21 requires each City Department, as stipulated in Chapter 12D.A.6.A(1) and 12D.A.18 ( C ) of  
22 San Francisco's Administrative Code, to submit a comprehensive strategic plan detailing  
23 allocation of resources related to the implementation of the Diversity Tracking System, an  
24 accompanying budget itemizing the funds required as well as a list of assigned staff.
