12 with Addus Healthcare, on file with the Clerk of the Board of Supervisors in File No. 01-1000,
13 which is hereby declared to be a part of this resolution as if set forth fully herein; and,

14 WHEREAS, The Department of Human Services has allocated funds in their budget to
15 provide IHSS through contracted providers; and

16 WHEREAS, The City and County of San Francisco Board of Supervisors approved the
17 Department of Human Services budget; and

18 WHEREAS, The Human Services Commission has recommended approval of this
19 contract modification with Addus Healthcare at its meeting of August 23, 2001; now, therefore,
20 be it

21 **RESOLVED, That the Board of Supervisors hereby approves the retroactive**
22 **modification of this contract with Addus Healthcare for the period of July 1, 2001 to January**
23 **31, 2002, in the increased amount of \$4,182,526, for a total contract amount of \$21,379,697.**




