1 [Initiative Ordinance - Business and Tax Regulations Code - Enact Gross Receipts Tax and  
Phase Out Payroll Expense Tax]

2 Motion ordering submitted to the voters an: "Ordinance amending the Business and  
3 Tax Regulations Code to: 1) enact a new Article 12-A-1 (Gross Receipts Tax  
4 Ordinance) to impose a gross receipts tax and an administrative office tax on persons  
5 engaging in business activities in San Francisco; 2) amend Article 12-A (Payroll  
6 Expense Tax Ordinance) to reduce business payroll expense tax rates based on the  
7 amount of gross receipts tax collected under Article 12-A-1 (Gross Receipts Tax  
8 Ordinance); 3) amend Article 12 (Business Registration Ordinance) to establish  
9 business registration fees based on gross receipts and amend the current business  
10 registration fees to generate approximately \$13 million in estimated additional revenue;  
11 4) amend Article 12-A (Payroll Expense Tax Ordinance) to add a sunset date to the  
12 surplus business tax revenue credit; and 5) amend Article 6 (Common Administrative  
13 Provisions) to establish requirements for filing a tax return under Article 12-A-1 (Gross  
14 Receipts Tax Ordinance), establish penalties for non-filing, and amend the  
15 requirements for filing payroll expense tax returns and penalties for non-filing to  
16 conform to the new gross receipts tax" at an election to be held on November 6, 2012.

19 MOVED, That the Board of Supervisors hereby submits the following Ordinance to the  
20 voters of the City and County of San Francisco, at an election to be held on November 6,  
21 2012.

22 Ordinance amending the Business and Tax Regulations Code to: 1) enact a new  
23 Article 12-A-1 (Gross Receipts Tax Ordinance) to impose a gross receipts tax and an  
24 administrative office tax on persons engaging in business activities in San Francisco;

1 2) amend Article 12-A (Payroll Expense Tax Ordinance) to reduce business payroll  
2 expense tax rates based on the amount of gross receipts tax collected under  
3 Article 12-A-1 (Gross Receipts Tax Ordinance); 3) amend Article 12 (Business  
4 Registration Ordinance) to establish business registration fees based on gross  
5 receipts and amend the current business registration fees to generate approximately  
6 \$13 million in estimated additional revenue; 4) amend Article 12-A (Payroll Expense Tax  
7 Ordinance) to add a sunset date to the surplus business tax revenue credit; and  
8 5) amend Article 6 (Common Administrative Provisions) to establish requirements for  
9 filing a tax return under Article 12-A-1 (Gross Receipts Tax Ordinance), establish  
10 penalties for non-filing, and amend the requirements for filing payroll expense tax  
11 returns and penalties for non-filing to conform to the new gross receipts tax.

14 Be it ordained by the People of the City and County of San Francisco:

15  
16 Section 1. The Planning Department has determined that the actions contemplated in  
17 this Ordinance comply with the California Environmental Quality Act (California Public  
18 Resources Code Section 21000 et seq.). Said determination is on file with the Clerk of the  
19 Board of Supervisors in File No. 120681 and is incorporated herein by reference.  
20

21 Section 2. Pursuant to Article XIII C of the Constitution of the State of California, this  
22 Ordinance shall be submitted to the qualified electors of the City and County of  
23 San Francisco, at the November 6, 2012 consolidated general election.  
24  
25

1 Section 3. The San Francisco Business and Tax Regulations Code is hereby amended  
2 by adding Article 12-A-1 to read as follows:

3  
4 **SEC. 950. FINDINGS AND PURPOSE.**

5 The voters hereby find and declare as follows:

6 1. San Francisco is the only major city in California that levies its entire business tax on  
7 payroll expense. This exclusive payroll-based tax discourages job creation and economic growth,  
8 lowers wages, and provides an unstable revenue stream.

9 2. San Francisco currently charges a flat rate on its payroll expense tax base. Instituting a  
10 tiered rate structure, in which businesses are taxed based on their gross receipts, will better distribute  
11 the tax burden according to a business's ability to pay.

12 3. Gross receipts is the most common business tax base among California's largest cities.

13 4. Amending San Francisco's business tax system to include a gross receipts tax will promote  
14 revenue stability by diversifying the tax base.

15 5. The rate schedules and the small business exemption for businesses with receipts under  
16 \$1,000,000 provide particular tax relief to small businesses.

17 6. The legislation will gradually phase in the new gross receipts tax over a five-year period,  
18 beginning in tax year 2014, to allow businesses time to adjust to the change and to minimize the risk to  
19 the City and to taxpayers of instability in City revenues during the transition from the payroll expense  
20 tax to a gross receipts tax.

21 7. Also beginning in tax year 2014, the payroll expense tax will be adjusted, over the same  
22 period, in increments that are consistent with the phase in of the gross receipts tax.

23 8. Each year during the phase-in period, the formula dictates an increase in the gross receipts  
24 tax rate and an adjustment in the payroll expense tax rate that is expected to reduce the payroll expense  
25 tax rate to zero by or before 2018. The Controller will calculate the annual increase in the gross

1 receipts tax rate and the adjustment in the payroll expense tax rate by applying formulas specified in  
2 this legislation.

3  
4 **SEC. 951. SHORT TITLE.**

5 This Article shall be known as the "Gross Receipts Tax Ordinance" and the tax this Article  
6 imposes shall be known as the "Gross Receipts Tax."

7  
8 **SEC. 952. DEFINITIONS.**

9 Except where the context otherwise requires, the terms used in this Article shall have the  
10 meanings given to them in Sections 6.2-1 et seq. of Article 6 and in Article 12-A.

11  
12 **SEC. 952.1. ADVANCE PAYMENT.**

13 "Advance payment" means a nonrefundable payment for the purchase of property or services to  
14 be delivered or performed in the future.

15  
16 **SEC. 952.2. CASH DISCOUNT.**

17 "Cash discount" means a deduction from the invoice price of goods or charge for services  
18 which is allowed if the bill is paid on or before a specified date, or paid in cash rather than by credit  
19 card.

20  
21 **SEC. 952.3. GROSS RECEIPTS.**

22 (a) "Gross receipts" means the total amounts received or accrued by a person from whatever  
23 source derived, including, but not limited to, amounts derived from sales, services, dealings in  
24 property, interest, rent, royalties, dividends, licensing fees, other fees, commissions and distributed  
25 amounts from other business entities. Except as otherwise specifically provided in this Article, gross

1 receipts includes but is not limited to all amounts that constitute gross income for federal income tax  
2 purposes. Gross receipts includes all receipts, cash, credits and property of any kind or nature and  
3 including any amount for which credit is allowed by the seller to the purchaser, without any deduction  
4 therefrom on account of the cost of the property sold, the cost of materials used, labor or service costs.  
5 interest paid or payable, losses or any other expense whatsoever, except that cash discounts allowed or  
6 taken on sales shall not be included as gross receipts. Gross receipts, including advance payments,  
7 shall be included in a taxpayer's gross receipts at the time such receipts are recognized as revenue for  
8 federal income tax reporting purposes.

9 (b) "Gross receipts" with respect to any lease or rental shall include payment for any services  
10 that are part of the lease or rental, whether received in money or otherwise, that are paid to, on behalf  
11 of, or for the benefit of, the lessor, and all receipts, cash, credits, property of any kind or character and  
12 the fair market value of services so paid or rendered by the lessee.

13 (c) Treatment of Taxes. "Gross receipts" shall not include the amount of any federal, state, or  
14 local tax imposed on or with respect to retail sales whether imposed upon the retailer or upon the  
15 purchaser and regardless of whether the amount of tax is stated as a separate charge, or such part of  
16 the sales price of any property previously sold and returned by the purchaser to the seller which is  
17 refunded by the seller by way of cash or credit allowances given or taken as part payment on any  
18 property so accepted for resale. Gross receipts shall also not include any federal, state or local tax  
19 imposed upon a person for which that person is reimbursed by means of a separately stated charge to a  
20 purchaser, lessee, licensee or customer. Gross receipts shall not include any amount of third-party  
21 taxes that a taxpayer collects from or on behalf of the taxpayer's customers and remits to the  
22 appropriate governmental entity imposing such tax. Gross receipts shall not include any tax refunds  
23 received by a person from a governmental entity. Gross receipts shall include any federal, state or  
24 local tax not specifically excluded in this subsection.

1           (d) "Gross receipts" shall not include any amount received from or charged to any person that  
2 is a related entity to the taxpayer. Nor shall gross receipts include any grants received from  
3 governmental entities or any gifts. Gross receipts also shall not include any distributions (such as  
4 dividends, interest and other returns on capital) from an entity treated as a pass-through entity for  
5 federal income tax purposes, provided such distributions are derived exclusively from an investment in  
6 such entity, and that such entity is a person or a member of a combined group subject to the gross  
7 receipts tax.

8           (e) "Gross receipts" from the sale or exchange of stocks or other similar written instruments  
9 evidencing a right to participate in the assets of any business, or of bonds or other evidence of  
10 indebtedness, or of any other marketable securities (collectively referred to in this Article as "financial  
11 instruments") or of any real property shall not include the cost to acquire the financial instrument(s),  
12 or real property sold or otherwise exchanged or converted. To the extent that any loss on the sale or  
13 exchange of financial instruments reduces the gross income of a person for federal income tax purposes  
14 in the year the loss is incurred, that loss shall reduce gross receipts from the sale or exchange of  
15 financial instruments, but in no event shall those receipts be less than zero, and in no event may any  
16 such loss be carried back or carried forward to reduce gross receipts in a tax year other than that in  
17 which the loss was incurred.

18           (f) No person shall be deemed to be engaging in business in the City if that person is an  
19 individual whose only gross receipts within the City are derived from investments of that individual's  
20 own funds in financial instruments. Gross receipts of an individual shall not include interest,  
21 dividends, capital gains and similar items or investment income earned from the investment of that  
22 individual's own capital.

23           (g) For purposes of this Article and Article 12, and notwithstanding Section 6.2-12 of Article 6,  
24 no person shall be deemed to be engaging in business within the City if its activities in the City consist  
25 solely of one or more of the following:

- 1                   (1) contracting with, or otherwise using the services of, any investment advisor or  
2 affiliate thereof which is not a related entity;  
3                   (2) maintaining documents of formation, incorporation, or registration within the City;  
4                   (3) being an owner, member, or other participant in an entity engaging in business  
5 within the City which is a pass-through entity for federal income tax purposes; or  
6                   (4) having trustees or directors who meet or reside within the City.

7  
8 **SEC. 952.4. NAICS CODE.**

9                   "NAICS code" means the numerical classification for business activities established in the  
10 North American Industry Classification System used by federal governmental agencies to classify  
11 business establishments; references in this Article to particular numerical NAICS codes are intended to  
12 apply the definitions and descriptions adopted in that system as of the effective date of this Article.

13  
14 **SEC. 952.5. RELATED ENTITY.**

15                   A person is a "related entity" to a taxpayer if that person and the taxpayer are permitted or  
16 required under Section 25102 of the California Revenue and Taxation Code, or any successor, to have  
17 their income reflected on the same combined report. For purposes of this Article, if two or more  
18 persons derive gross receipts solely from sources within California, and their business activities are  
19 such that, if conducted both within and outside California, a combined report would be required under  
20 the California Revenue and Taxation Code, or any successor, then those persons are related entities  
21 regardless of whether they file a combined report under the California Revenue and Taxation Code, or  
22 successor.



1 SEC. 952.6. SALE AND SELL.

2 "Sale" and "sell" mean the making of any transfer of title, in any manner or by any means  
3 whatsoever, to property for a price, and to the serving, supplying or furnishing, for a price, of any  
4 property fabricated or made at the special order of consumers who do or who do not furnish directly or  
5 indirectly the specifications or materials therefor. A transaction whereby the possession of property is  
6 transferred but the seller retains the title as a security for the payment of the price shall likewise be  
7 deemed a sale.

8  
9 SEC. 953. IMPOSITION OF GROSS RECEIPTS TAX.

10 (a) Except as otherwise provided under this Article, the City imposes and every person  
11 engaging in business within the City shall pay an annual gross receipts tax measured by the person's  
12 gross receipts from all taxable business activities attributable to the City. A person's liability for the  
13 gross receipts tax shall be calculated according to Sections 953.1 through 953.7.

14 (b) The gross receipts tax is a privilege tax imposed upon persons engaging in business within  
15 the City for the privilege of engaging in a business or occupation in the City. The gross receipts tax is  
16 imposed for general governmental purposes. Proceeds from the tax shall be deposited in the City's  
17 general fund and may be expended for any purposes of the City.

18 (c) The voters intend by adopting this measure to authorize application of the gross receipts tax  
19 in the broadest manner consistent with the provisions of this Article and the requirements of the  
20 California Constitution, the United States Constitution, and any other applicable provision of federal  
21 and state law.

22 (d) The gross receipts tax imposed under this Article is in addition to the payroll expense tax  
23 imposed under Article 12-A. Persons not otherwise exempt from the gross receipts tax or payroll  
24 expense tax shall pay both taxes. Persons exempt from either the gross receipts tax or payroll expense  
25 tax, but not both, shall pay the tax from which they are not exempt.

1           (e) Except for subsection (d) of this Section, the tax on Administrative Office Business Activities  
2 imposed by Section 953.8 is intended as a complementary tax to the gross receipts tax, and shall be  
3 considered a gross receipts tax for purposes of this Section.

4  
5 **SEC. 953.1. GROSS RECEIPTS TAX APPLICABLE TO RETAIL TRADE; WHOLESAL**  
6 **TRADE; AND CERTAIN SERVICES.**

7           (a) The base gross receipts tax rate provided by this Section is applicable to the business  
8 activities of retail trade, wholesale trade, and certain services. Commencing on the operative date of  
9 the Gross Receipts Tax Ordinance, the Controller shall compute the tax rate in accordance with  
10 Section 959, but the base tax rate provided by this Section is:

11           0.075% (e.g., \$0.75 per \$1,000) for gross receipts between \$0 and \$1,000,000

12           0.100% (e.g., \$1 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

13           0.150% (e.g., \$1.50 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

14           0.175% (e.g., \$1.75 per \$1,000) for gross receipts over \$25,000,000

15           (b) Retail trade includes the activity of retailing any type of personal property, generally  
16 without significantly transforming its characteristics, and rendering services incidental to the retail  
17 sale of property; it includes business activity described in NAICS codes 44 and 45.

18           (c) Wholesale trade includes the activity of wholesaling property, generally without  
19 transformation, and rendering services incidental to the sale of property on a wholesale basis; it  
20 includes business activity described in NAICS code 42.

21           (d) Certain services includes the repair and maintenance services, personal and laundry  
22 services, and religious, grantmaking, civic, professional and similar organizations that are not  
23 otherwise exempt; it includes business activity described in NAICS codes 811, 812 and 813.

1           (e) The amount of gross receipts from retail trade activities and from wholesale trade activities  
2 subject to the gross receipts tax shall be one-half of the amount determined under Section 956.1 plus  
3 one-half of the amount determined under Section 956.2.

4           (f) The amount of gross receipts from certain services activities subject to the gross receipts tax  
5 shall be the total amount determined under Section 956.2.

6  
7 **SEC. 953.2. GROSS RECEIPTS TAX APPLICABLE TO MANUFACTURING;**  
8 **TRANSPORTATION AND WAREHOUSING; INFORMATION; BIOTECHNOLOGY; CLEAN**  
9 **TECHNOLOGY; AND FOOD SERVICES.**

10           (a) The base gross receipts tax rate provided by this Section is applicable to the business  
11 activities of manufacturing, transportation and warehousing, information, biotechnology, clean  
12 technology, and food services. Commencing on the operative date of the Gross Receipts Tax  
13 Ordinance, the Controller shall compute the tax rate in accordance with Section 959, but the base tax  
14 rate provided by this Section is:

15           0.125% (e.g., \$1.25 per \$1,000) for gross receipts between \$0 and \$1,000,000

16           0.200% (e.g., \$2 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

17           0.350% (e.g., \$3.50 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

18           0.450% (e.g., \$4.50 per \$1,000) for gross receipts over \$25,000,000

19           (b) Manufacturing includes the activity of transforming materials, substances or components  
20 into new products by mechanical, physical or chemical means; it includes the activity of assembling  
21 component parts of manufactured products; it includes business activity described in NAICS codes 31,  
22 32 and 33.

23           (c) Transportation and warehousing includes the activities of providing transportation of  
24 passengers and/or goods, warehousing and storage for goods, scenic and sightseeing transportation,  
25

1 and support activities related to modes of transportation; it includes business activity described in  
2 NAICS codes 48 and 49.

3 (d) Information includes producing and distributing information or cultural products;  
4 providing the means to transmit or distribute those products; and processing data; it includes business  
5 activity described in NAICS code 51.

6 (e) For purposes of this Article, biotechnology includes the activity of biotechnology business  
7 as defined in Section 906.1 of Article 12-A, and clean technology includes the activity of clean  
8 technology business as defined in Section 906.2 of Article 12-A.

9 (f) Food services includes the activity of preparing meals, snacks and/or beverages to customer  
10 order for immediate on-premises or off-premises consumption; it includes drinking places; it includes  
11 business activity described in NAICS code 722.

12 (g) The amount of gross receipts from all business activities described in this Section subject to  
13 the gross receipts tax shall be one-half of the amount determined under Section 956.1 plus one-half of  
14 the amount determined under Section 956.2.

15  
16 **SEC. 953.3. GROSS RECEIPTS TAX APPLICABLE TO ACCOMMODATIONS; UTILITIES;**  
17 **AND ARTS, ENTERTAINMENT AND RECREATION.**

18 (a) The base gross receipts tax rate provided by this Section is applicable to each of the  
19 following business activities: accommodations; utilities; and arts, entertainment and recreation.  
20 Commencing on the operative date of the Gross Receipts Tax Ordinance, the Controller shall compute  
21 the tax rate in accordance with Section 959, but the base tax rate provided by this Section is:

22 0.300% (e.g., \$3 per \$1,000) for gross receipts between \$0 and \$1,000,000

23 0.325% (e.g., \$3.25 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

24 0.325% (e.g., \$3.25 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

25 0.400% (e.g., \$4 per \$1,000) for gross receipts over \$25,000,000

1 (b) Accommodations includes the activity of providing lodging or short-term accommodations  
2 for travelers, vacationers, or others; it includes business activity described in NAICS code 721.

3 (c) Utilities includes the activities of the generation, transmission and distribution of electric  
4 power, the distribution of natural gas, the provision and distribution of steam supply, the treatment and  
5 distribution of water supply, and the removal of sewage; it includes business activity described in  
6 NAICS code 22; it excludes establishments primarily engaged in waste management services.

7 (d) Arts, entertainment and recreation include the activity of operating facilities or providing  
8 services to meet cultural, entertainment or recreational interests of customers or patrons; it includes  
9 business activity described in NAICS code 71.

10 (e) The amount of gross receipts and from accommodations subject to the gross receipts tax  
11 shall be the total amount of gross receipts derived from or related to properties located or used within  
12 the City.

13 (f) The amount of gross receipts from utilities subject to the gross receipts tax shall be one-half  
14 of the amount determined under Section 956.1 plus one-half of the amount determined under  
15 Section 956.2.

16 (g) The amount of gross receipts from arts, entertainment and recreation subject to the gross  
17 receipts tax shall be the total amount determined under Section 956.2.

18  
19 **SEC. 953.4. GROSS RECEIPTS TAX APPLICABLE TO PRIVATE EDUCATION AND HEALTH**  
20 **SERVICES; ADMINISTRATIVE AND SUPPORT SERVICES; AND MISCELLANEOUS**  
21 **BUSINESS ACTIVITIES.**

22 (a) The base gross receipts tax rate provided by this Section is applicable to the business  
23 activities of private education and health services, and administrative and support services. This rate  
24 also applies to all business activities not otherwise exempt and not elsewhere subjected to a gross  
25 receipts tax rate or an administrative office tax by this Article. Commencing on the operative date of

1 the Gross Receipts Tax Ordinance, the Controller shall compute the tax rate in accordance with  
2 Section 959, but the base tax rate provided by this Section is:

3 0.525% (e.g., \$5.25 per \$1,000) for gross receipts between \$0 and \$1,000,000

4 0.550% (e.g., \$5.50 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

5 0.600% (e.g., \$6 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

6 0.650% (e.g., \$6.50 per \$1,000) for gross receipts over \$25,000,000

7 (b) Private education and health services include the activity by persons other than  
8 governmental agencies of providing instruction and training in any subject, or of providing health care  
9 or social assistance for individuals; it includes business activity described in NAICS codes 61 and 62.

10 (c) Administrative and support services includes the activity of performing routine support  
11 activities for the day-to-day business activities of others; it includes business activity described in  
12 NAICS code 56.

13 (d) The amount of gross receipts from all business activities described in this Section subject to  
14 the gross receipts tax shall be determined under Section 956.2.

15  
16 **SEC. 953.5. GROSS RECEIPTS TAX APPLICABLE TO CONSTRUCTION.**

17 (a) The base gross receipts tax rate provided by this Section is applicable to the business  
18 activity of construction. Commencing on the operative date of the Gross Receipts Tax Ordinance, the  
19 Controller shall compute the tax rate in accordance with Section 959, but the base tax rate provided by  
20 this Section is:

21 0.300% (e.g., \$3 per \$1,000) for gross receipts between \$0 and \$1,000,000.

22 0.350% (e.g., \$3.50 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000

23 0.400% (e.g., \$4 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000

24 0.450% (e.g., \$4.50 per \$1,000) for gross receipts over \$25,000,000

1           **(b) Construction includes the activity of preparing sites for, subdividing land for, or working**  
2 **on, buildings or engineering projects (including highways and utility systems); it includes business**  
3 **activity described in NAICS code 23.**

4           **(c) The amount of gross receipts from construction subject to the gross receipts tax shall be**  
5 **one-half of the amount determined under Section 956.1 plus one-half of the amount determined under**  
6 **Section 956.2. The amount of gross receipts so determined shall then be reduced by any amounts**  
7 **which were included in a person's gross receipts within the City pursuant to Section 956.1, and which**  
8 **that person paid to a subcontractor possessing a valid business registration certificate with the City**  
9 **during the tax year. There shall be no reduction for any other costs, including without limitation costs**  
10 **for materials, fees, equipment, or other services. In order to claim such a reduction, a person must**  
11 **maintain an itemized schedule of payments to subcontractors and information sufficient to enable the**  
12 **Tax Collector to verify that the subcontractor possessed a valid business registration certificate with**  
13 **the City.**

14  
15 **SEC. 953.6. GROSS RECEIPTS TAX APPLICABLE TO FINANCIAL SERVICES; INSURANCE;**  
16 **AND PROFESSIONAL, SCIENTIFIC AND TECHNICAL SERVICES.**

17           **(a) The base gross receipts tax rate provided by this Section is applicable to the business**  
18 **activities of financial services; insurance; and professional, scientific and technical services.**  
19 **Commencing on the operative date of the Gross Receipts Tax Ordinance, the Controller shall compute**  
20 **the tax rate in accordance with Section 959, but the base tax rate provided by this Section is:**

21           **0.400% (e.g., \$4 per \$1,000) for gross receipts between \$0 and \$1,000,000**

22           **0.450% (e.g., \$4.50 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000**

23           **0.500% (e.g., \$5 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000**

24           **0.550% (e.g., \$5.50 per \$1,000) for gross receipts over \$25,000,000**

1           **(b) Financial services includes the activities of engaging in or facilitating financial**  
2 **transactions; it includes business activities described in NAICS codes 521, 522 and 523. Any person**  
3 **engaged in financial services business activities who deals in financial instruments as a principal shall**  
4 **include in gross receipts all trading profits, dividends and interest derived from those financial**  
5 **instruments, except to the extent provided in Section 952.3(f).**

6           **(c) Insurance includes the activities of facilitating or supporting the pooling of risk by**  
7 **underwriting insurance and annuities; the activities covered by this Section include those of persons**  
8 **not exempt from the gross receipts tax based on business activities described in NAICS code 524.**

9           **(d) Professional, scientific and technical services includes the activity of providing for others,**  
10 **specialized professional, scientific, or technical services that require a high degree of expertise and**  
11 **training; it includes business activity described in NAICS code 54.**

12           **(e) The amount of gross receipts from the activities described in this Section subject to the**  
13 **gross receipts tax shall be the amount determined under Section 956.2.**

14  
15 **SEC. 953.7. GROSS RECEIPTS TAX APPLICABLE TO REAL ESTATE AND RENTAL AND**  
16 **LEASING SERVICES.**

17           **(a) The base gross receipts tax rate provided by this Section is applicable to the business**  
18 **activities of real estate and rental and leasing services. Commencing on the operative date of the**  
19 **Gross Receipts Tax Ordinance, the Controller shall compute the tax rate in accordance with**  
20 **Section 959, but the base tax rate provided by this Section is:**

21           **0.300% (e.g., \$3 per \$1,000) for gross receipts between \$0 and \$1,000,000**

22           **0.325% (e.g., \$3.25 per \$1,000) for gross receipts between \$1,000,001 and \$2,500,000**

23           **0.325% (e.g., 3.25 per \$1,000) for gross receipts between \$2,500,001 and \$25,000,000**

24           **0.400% (e.g., \$4 per \$1,000) for gross receipts over \$25,000,000**



1 (b) Real estate and rental and leasing services includes the activities of renting, leasing, or  
2 otherwise allowing the use of tangible or intangible assets, and the activity of providing related  
3 services; it includes business activity described in NAICS code 53.

4 (c) The amount of gross receipts from real estate and rental and leasing services subject to the  
5 gross receipts tax shall be the total amount of gross receipts derived from or related to properties  
6 located or used within the City. Gross receipts shall not include amounts derived from or related to  
7 properties located or used outside the City.

8  
9 **SEC. 953.8. TAX ON ADMINISTRATIVE OFFICE BUSINESS ACTIVITIES.**

10 (a) Except as provided in this Section, notwithstanding any other provision of this Article and  
11 in lieu of the other taxes provided by this Article and Article 12-A for any person or combined group,  
12 every person engaging in business within the City as an administrative office, as defined below, shall  
13 pay an annual administrative office tax measured by its total payroll expense that is attributable to the  
14 City. If a person is a member of a combined group, then its tax shall be measured by the total payroll  
15 expense of the combined group attributable to the City. Such combined group shall pay only the  
16 administrative office tax. The administrative office tax rate for each tax year is 1.500 percent.

17 (b) "Engaging in business within the City as an administrative office" means that:

18 (1) a person is engaging in business within the City during the tax year and over  
19 50 percent of the total combined payroll expense within the City of that person and its related entities  
20 for the preceding tax year was associated with providing administrative or management services  
21 exclusively to that person or related entities;

22 (2) the total combined number of employees of that person and its related entities within  
23 the United States as of the last day of the preceding tax year exceeded 1,000; and

24 (3) the total combined gross receipts of that person and its related entities reported on  
25 United States federal income tax return(s) for the preceding tax year exceeded \$1,000,000,000.

1           (c) For purposes of subsection (b) only, a related entity shall include any person who could be  
2 included in the same combined report under California Revenue and Taxation Code Section 25102 but  
3 for the existence of a water's edge election under Section 25110 of that Code.

4           (d) "Administrative or management services" comprises oversight services from executive staff  
5 and routine support services on an enterprise-wide basis, such as recordkeeping, risk management,  
6 personnel administration, legal, accounting, market research and analysis, and training services; it  
7 does not include sales personnel or personnel actively engaged in marketing, research and  
8 development, direct customer service, and product support services. The Tax Collector is authorized to  
9 classify in its reasonable discretion which personnel employed by any person provide administrative or  
10 management services.

11           (e) A person provides administrative office services exclusively for itself or a related entity only  
12 if the final recipient of those services is at a location where that person or a related entity conducts  
13 business activities.

14           (f) "Payroll expense" for purposes of this Section shall have the meaning given to that term by  
15 Sections 902.1 et seq. of Article 12-A, except that Section 902.1(b) of Article 12-A shall not apply for  
16 purposes of determining whether a person is engaging in business within the City as an administrative  
17 office. Section 902.1(b) shall apply for all other purposes under this Section. The portion of the  
18 payroll expense of a person or combined group that is attributable to the City shall be determined as  
19 set forth in Section 904 of Article 12-A.

20           (g) In addition to the administrative office tax provided in subsection (a), any person engaging  
21 in business within the City as an administrative office exclusively for itself or a related entity shall  
22 apply for a registration certificate and pay a registration fee, as provided in Article 12.

23           (h) Except as provided in this Section, the provisions of Article 6 and Article 12 apply to the  
24 administrative office tax.

1 SEC. 953.9. PERSONS OR COMBINED GROUPS ENGAGED IN MULTIPLE BUSINESS  
2 ACTIVITIES.

3 If a person, or a combined group as described in Section 956.3, engages in business activities  
4 described in more than one of Sections 953.1 through 953.7, inclusive, of this Article, the rate or rates  
5 of gross receipts tax to be applied to that person or group, and the method for determining gross  
6 receipts in the City, shall be determined as follows:

7 (a) If more than 80 percent of its gross receipts, determined in accordance with Section 956,  
8 are derived from business activities described in only one of Sections 953.1 through 953.7, inclusive,  
9 then the rules of that applicable Section apply to all of its gross receipts derived from all business  
10 activities.

11 (b) If its business activities in the City are described in more than one of Sections 953.1  
12 through 953.7, inclusive, and subsection (a) of this Section does not apply, then such person or  
13 combined group shall separately compute the gross receipts tax for each set of business activities as  
14 provided in the Section applicable to that particular set of business activities, modified as follows:

15 (1) if the set of business activities described in any of Sections 953.1 through 953.7,  
16 inclusive, generates less than 20 percent of the total gross receipts of the person or group, then the  
17 receipts and payroll of any such set of activities may be combined for all purposes related to computing  
18 the gross receipts tax with whichever set of that person's or group's activities are taxed at the highest  
19 rate;

20 (2) the small business exemption provided in Section 954.1 shall apply only if the sum of  
21 receipts within the City from all sets of business activities does not exceed \$1,000,000 in total;

22 (3) the progressive rates described in Sections 953.1 through 953.7 apply on an  
23 aggregate basis for businesses with multiple sets of activities;

24 (4) the applicable rate for each set of business activities shall be determined in  
25 numbered order of the Sections describing each set of business activities; i.e., the gross receipts and tax

1 for business activities described in Section 953.1 should be determined first, Section 953.2 second, and  
2 so on;

3 (5) the rate(s) applicable to any set of activities after the first shall be determined by  
4 adding together the gross receipts determined for all previous sets of activities and applying the rate  
5 scale commencing with the total gross receipts so determined; and

6 (6) the gross receipts tax liability for the person or combined group shall be the sum of  
7 the liabilities for each set of business activities.

8  
9 **SEC. 954. EXEMPTIONS AND EXCLUSIONS.**

10 (a) Except as provided in subsection (b) of this Section, an organization that is exempt from  
11 income taxation by Chapter 4 (commencing with Section 23701) of Part 11 of Division 2 of the Revenue  
12 and Taxation Code or Subchapter F (commencing with Section 501) of Chapter 1 of Subtitle A of the  
13 Internal Revenue Code of 1986, as amended, as qualified by Sections 502, 503, 504 and 508 of the  
14 Internal Revenue Code of 1986, as amended, shall be exempt from taxation under this Article, only so  
15 long as those exemptions continue to exist under state or federal law.

16 (b) An organization otherwise exempt from income taxation under subsection (a) that is  
17 directly engaged within the City in an unrelated trade or business within the meaning of Section 513(a)  
18 of the Internal Revenue Code of 1986, as amended, and has, from its own operations, unrelated  
19 business taxable income within the meaning of Section 512(a)(1) of the Internal Revenue Code of 1986,  
20 as amended, shall pay the gross receipts tax on its gross receipts from its unrelated trade or business  
21 activities that are attributable to the City. If it is impracticable, unreasonable or improper to allocate  
22 such organization's gross receipts as aforesaid either because of the particular nature of the  
23 organization's unrelated trade or business or for any other reason, then the amount of gross receipts  
24 reasonably attributable to the organization's unrelated trade or business in the City shall be  
25 determined on the basis of all of the relevant facts and circumstances of the particular case, in

1 accordance with any rulings or regulations issued or promulgated by the Tax Collector for this  
2 purpose.

3 (c) Gross receipts as defined in Section 952.3 shall not include receipts from business activities  
4 if, and only so long as and to the extent that, the City is prohibited from taxing such receipts under the  
5 Constitution or laws of the United States or under the Constitution or laws of the State of California.

6 (d) Rent Controlled Buildings Exclusion. A person subject to the tax may exclude from gross  
7 receipts in any tax year 50 percent of the total amount received from the rental of real property to  
8 tenants in occupancy at any location in the City, which is subject to limits on rent increases pursuant to  
9 the Residential Rent Stabilization and Arbitration Ordinance, San Francisco Administrative Code,  
10 Chapter 37, Section 37.1 et seq.

11 (e) Exclusion of Certain Sales of Real Property. Gross receipts as defined in Section 952.3  
12 shall not include receipts from any sales of real property with respect to which the Real Property  
13 Transfer Tax imposed by Article 12-C has been paid to the City.

14 (f) For only so long as and to the extent that the City is prohibited from imposing the tax under  
15 this Article, the following persons shall be exempt from the gross receipts tax:

16 (1) Banks and financial corporations exempt from local taxation under Article XIII,  
17 Section 27 of the California Constitution and Revenue and Taxation Code Section 23182;

18 (2) Insurance companies exempt from local taxation under Article XIII, Section 28 of  
19 the California Constitution;

20 (3) Persons engaging in business as a for-hire motor carrier of property under Revenue  
21 and Taxation Code Section 7233;

22 (4) Persons engaging in intercity transportation as a household goods carrier under  
23 Public Utilities Code Section 5327;

24 (5) Charter-party carriers operating limousines that are neither domiciled nor maintain  
25 a business office within the City under Public Utilities Code Section 5371.4; and

1                   (6) Any person upon whom the City is prohibited under the Constitution or laws of the  
2 State of California from imposing the gross receipts tax.

3                   (g) To the extent that any taxpayer has paid a substantially similar tax to any other taxing  
4 jurisdiction on any gross receipts attributed to the City and taxed under this Article, the tax paid to  
5 such taxing jurisdiction shall be credited against the tax due under this Article; in no event shall this  
6 credit reduce the taxpayer's liability to less than zero.

7  
8 **SEC. 954.1. SMALL BUSINESS EXEMPTION.**

9                   (a) Notwithstanding any other provision of this Article, a "small business enterprise," as  
10 hereinafter defined for purposes of this Article 12-A-1, shall be exempt from payment of the gross  
11 receipts tax, nevertheless, a small business enterprise shall pay the annual registration fee pursuant to  
12 Section 855 of Article 12.

13                   (b) For purposes of this Article 12-A-1, the term "small business enterprise" shall mean and  
14 include any person or combined group, except for a lessor of residential real estate:

15                   (1) Whose gross receipts within the City for the preceding tax year did not exceed  
16 \$1,000,000; and

17                   (2) Who filed a tax return by the last day of February for the preceding tax year, if that  
18 person or group had gross receipts in the City of over \$500,000. If a person is required to file a tax  
19 return under this Section, and fails to file a return by that date, the taxpayer shall be subject to a  
20 penalty as specified in subsection (c).

21                   (c) In lieu of the penalty specified in Section 6.17-3 of Article 6 for failing to file a return, any  
22 person who otherwise qualifies for the small business exemption set forth in this Section, and who had  
23 gross receipts in the City of over \$500,000, who fails to file a return by the last date of February shall  
24 pay a penalty as follows:

1           (1) The penalty for the first month, or fraction thereof, that the return is delinquent,  
2 shall be 5 percent of the amount of the tax liability, calculated without regard to the small business  
3 exemption in this Section. The penalty shall increase by an additional 5 percent each month, or  
4 fraction thereof, that the return is delinquent, up to a maximum of 20 percent of the tax liability. Any  
5 penalties remaining unpaid for a period of 90 days or more shall be subject to an additional penalty of  
6 20 percent of the amount of the tax liability excluding penalties and interest.

7           (2) Penalties are due and payable when assessed. Unpaid penalties, interest and fees  
8 shall accrue interest at the rate of 1 percent per month, or fraction thereof, from the date that they are  
9 assessed through the date of payment. The total amount of the penalties, interest and fees shall not  
10 exceed the amount of the person's gross receipts tax liability for the period but for the small business  
11 exemption.

12           (d) The Tax Collector may, at his or her discretion, reduce the penalty set forth in  
13 subsection (c) to not less than \$100 upon a showing that the late filing of the return was due to  
14 reasonable cause and not due to willful neglect.

15           (e) For purposes of this Article 12-A-1, and notwithstanding any other provision of this Section,  
16 a lessor of residential real estate is a "small business enterprise" if and only if the lessor leases fewer.  
17 than 4 units in any individual building. "Residential real estate" means real property where the  
18 primary use of or right to use the property is for the purpose of dwelling, sleeping or lodging other than  
19 as part of the business activity of accommodations. For purposes of determining whether a lessor of  
20 residential real estate is a small business enterprise, a lessor of residential real estate is treated as a  
21 separate person with respect to each individual building in which it leases residential real estate units,  
22 notwithstanding Section 6.2-15 of Article 6, or Section 956.3 of this Article. The provisions of this  
23 subsection apply only to leasing residential real estate units within a building, and not to any business  
24 activity related to other space, either within the same building or other buildings, which is not  
25

1 residential real estate. The Tax Collector is authorized to determine what constitutes a separate  
2 building and the number of units in a building.

3  
4 **SEC. 955. PERSONS DERIVING NO GROSS RECEIPTS FROM BUSINESS ACTIVITIES**  
5 **OUTSIDE THE CITY.**

6 Notwithstanding any other provision of this Article, any person subject to the gross receipts tax  
7 who derives non-exempt gross receipts from business activities within the City and derives no gross  
8 receipts from business activities outside the City is subject to tax on all non-exempt gross receipts.

9  
10 **SEC. 956. ALLOCATION AND APPORTIONMENT FOR ALL PERSONS DERIVING GROSS**  
11 **RECEIPTS FROM BUSINESS ACTIVITIES BOTH WITHIN AND OUTSIDE THE CITY.**

12 All persons deriving gross receipts from business activities both within and outside the City  
13 shall allocate and/or apportion their gross receipts to the City, using the rules set forth in Section 956.1  
14 and 956.2, in the manner directed in Sections 953.1 through 953.7, inclusive, and in Section 953.9 of  
15 this Article.

16  
17 **SEC. 956.1. ALLOCATION OF RECEIPTS FROM REAL, PERSONAL, TANGIBLE AND**  
18 **INTANGIBLE PROPERTY.**

19 (a) For all persons required to determine an amount of gross receipts pursuant to this Section,  
20 that amount shall be all non-exempt gross receipts within the City as determined hereunder.

21 (b) Gross receipts from the sale, lease, rental or licensing of real property are in the City if the  
22 real property is located in the City.

23 (c) Gross receipts from sales of tangible personal property are in the City if the property is  
24 delivered or shipped to a purchaser within the City regardless of the f.o.b. point or other conditions of  
25 the sale.



1 (d) Gross receipts from the rental, lease or licensing of tangible personal property are in the  
2 City if the property is located in the City.

3 (e) Gross receipts from services are in the City to the extent the purchaser of the services  
4 received the benefit of the services in the City.

5 (f) Gross receipts from intangible property are in the City to the extent the property is used in  
6 the City. In the case of financial instruments, sales are in the City if the customer is located in the City.

7  
8 **SEC. 956.2. APPORTIONMENT OF RECEIPTS BASED ON PAYROLL.**

9 (a) For all persons required to determine an amount of gross receipts pursuant to this Section,  
10 that amount shall be all combined gross receipts of the person multiplied by a fraction, the numerator  
11 of which is payroll in the City and the denominator of which is combined payroll.

12 (b) Combined gross receipts are the total worldwide gross receipts of the person and all  
13 related entities to the person, unless the election provided for in California Revenue and Taxation Code  
14 Section 25110 is in effect for the person, in which case combined gross receipts shall be computed  
15 consistently with the water's edge election, as set forth therein.

16 (c) Combined payroll is the total worldwide compensation paid by the person and all related  
17 entities to the person, unless the election provided for in California Revenue and Taxation Code  
18 Section 25110 is in effect for the person, in which case combined payroll shall be computed consistently  
19 with the water's edge election, as set forth therein. A person who has no combined payroll in a tax year  
20 shall have no gross receipts under this Section for that tax year.

21 (d) Payroll in the City is the total amount paid for compensation in the City by the person and  
22 by all related entities to the person.

23 (e) Compensation paid in the City shall be determined as set forth in Section 904 of  
24 Article 12-A.

1           (f) "Compensation" means wages, salaries, commissions and any other form of remuneration  
2 paid to employees for services. In the case of any person who has no employees, compensation shall  
3 also include all taxable income for federal income tax purposes of the owners or proprietors of such  
4 person who are individuals. Those owners or proprietors shall be treated as individuals to whom  
5 compensation is paid for purposes of subsection (e).

6           (g) The apportionment provided by this Section shall not include in either the numerator or the  
7 denominator any payroll of persons exempt from tax under subsections (a), (b), or (f) of Section 954.

8  
9           **SEC. 956.3. COMBINED RETURNS.**

10           A person engaging in business within the City must file gross receipts tax returns as provided in  
11 Article 6. Those returns must be filed on a combined basis with all of that person's related entities.  
12 That person, and all of that person's related entities, constitute a combined group. Every combined  
13 group must file a single return; the combined group may choose a single person to file the return on its  
14 behalf. Each person within the combined group engaging in business in the City must provide a power  
15 of attorney to the person filing the return, authorizing the person filing the return to file said return and  
16 to act on behalf of each person with respect to payments, refunds, audits, resolutions, and any other  
17 items related to the tax liability reflected in the return. The power of attorney shall be substantially in  
18 a form to be promulgated by the Tax Collector. Each return filed by a combined group constitutes a  
19 combined return under this Article and Article 6. The person filing any combined return shall pay the  
20 tax liability reflected on the return and any liability determined on audit at the time and in the manner  
21 set forth for returns and liabilities in Article 6.

22  
23           **SEC. 957. TAX COLLECTOR AUTHORIZED TO DETERMINE GROSS RECEIPTS.**

24           The Tax Collector may, in his or her reasonable discretion, independently establish a person's  
25 gross receipts and establish or reallocate gross receipts among related entities so as to fairly reflect the

1 gross receipts of all persons. This authority extends to determining whether any amount excluded from  
2 gross receipts by virtue of Section 952.3(f) is in whole or in part compensation or payment for services  
3 and thus included in gross receipts.

4  
5 **SEC. 958. ADMINISTRATION OF THE GROSS RECEIPTS TAX ORDINANCE.**

6 Except as otherwise provided under this Article, the Gross Receipts Tax Ordinance shall be  
7 administered pursuant to Article 6 of the San Francisco Business and Tax Regulations Code.

8  
9 **SEC. 959. RATE OF GROSS RECEIPTS TAX: CONTROLLER COMPUTATION.**

10 (a) Commencing on the operative date of the Gross Receipts Tax Ordinance, the Controller  
11 shall compute the rate of gross receipts tax for Sections 953.1 through 953.7 in accordance with  
12 subsection (b) of this Section. The Controller shall certify and publish such rates on or before  
13 September 1 of each year.

14 (b) Gross Receipts Tax Computation. The Controller shall compute the gross receipts tax rates  
15 for each tax year by multiplying each base rate in Sections 953.1 through 953.7 by the "Gross Receipts  
16 Tax Rate Adjustment Factor," which shall be determined according to the following table and formulas,  
17 but no gross receipts tax rate shall exceed the base rates provided by Sections 953.1 through 953.7.

Where: "EXP<sub>year</sub>" is the "Excess Payroll Expense Tax Revenue Factor," a percentage that reduces the gross receipts tax rate adjustment factor for a year in which the payroll expense tax rate determined under Section 903.1 of Article 12-A becomes zero, and which adjusts for excess payroll expense tax revenue collected for that tax year. The Controller shall compute EXP<sub>year</sub> according to the following table and formulas:

(1) In any year in which PAYRATE<sub>year</sub> is greater than zero, where PAYRATE<sub>year</sub> is determined under Section 903.1 of Article 12-A, EXP<sub>year</sub> is zero.

(2) In the first year in which PAYRATE<sub>year</sub> is zero, where PAYRATE<sub>year</sub> is determined under Section 903.1 of Article 12-A, EXP<sub>year</sub> shall be computed according to the following table and formulas. In subsequent years, GADJ<sub>year</sub> shall be the same value it was in the prior year:

The Controller shall certify and publish such rates by September 1 of that year, at which time the Controller's duty to compute, certify and publish the gross receipts tax rates shall cease.

(d) Notwithstanding any other provision of this Article, the gross receipts tax rates for 2019 and all future years shall be the rates in effect in tax year 2018. The Controller shall certify and publish such rates on or before September 1, 2019, at which time the Controller's duty to compute, certify and publish the payroll expense tax rate shall cease.

**SEC. 960. THE "PAYROLL EXPENSE TAX EXCLUSION" CREDIT.**

(a) "Payroll Expense Tax Exclusion Credit" means the dollar amount by which a person would have been able to reduce its payroll expense tax liability pursuant to the Enterprise Zone Tax Credit under Section 906A of Article 12-A, the Biotechnology Exclusion under Section 906.1 of Article 12-A, and/or the Clean Technology Business Exclusion under Section 906.2 of Article 12-A, as if the payroll expense tax were in full force and effect and calculated at a rate of 1½ percent.

21 agents solicits business within the City for all or part of any seven days during a tax year; or

7 file a return for the subject period on a form provided by the Tax Collector, regardless of

17 (b) Minimum Filing Amount.

18 (1) With respect to each tax year, the Tax Collector may exempt from the  
19 annual tax return filing requirement those taxpayers whose liability under the Payroll Expense  
20 Tax Ordinance, computed without regard to the small business exemption set forth in Section  
21 905-A of Article 12-A, is less than the Minimum Filing Amount for such tax year. For purposes  
22 of this Section, the Minimum Filing Amount shall be an amount of tax liability, computed  
23 without regard to such small business exemption, between zero and \$2,250. The Tax  
24 Collector shall specify the Minimum Filing Amount prior to the beginning of each tax year. If  
25 the Tax Collector fails to specify a Minimum Filing Amount prior to the start of a new tax year,



## LEGISLATIVE DIGEST

[Business and Tax Regulations Code – Enact Gross Receipts Tax and Phase Out Payroll Expense Tax]

**Ordinance amending the Business and Tax Regulations Code to: 1) enact a new Article 12-A-1 (Gross Receipts Tax Ordinance) to impose a gross receipts tax and an administrative office tax on persons engaging in business activities in San Francisco; 2) amend Article 12-A (Payroll Expense Tax Ordinance) to reduce business payroll expense tax rates based on the amount of gross receipts tax collected under Article 12-A-1 (Gross Receipts Tax Ordinance); 3) amend Article 12 (Business Registration Ordinance) to establish business registration fees based on gross receipts and amend the current business registration fees to generate approximately \$13 million in estimated additional revenue; 4) amend Article 12-A (Payroll Expense Tax Ordinance) to add a sunset date to the surplus business tax revenue credit; and 5) amend Article 6 (Common Administrative Provisions) to establish requirements for filing a tax return under Article 12-A-1 (Gross Receipts Tax Ordinance), establish penalties for non-filing, and amend the requirements for filing payroll expense tax returns and penalties for non-filing to conform to the new gross receipts tax.**

### Existing Law

The City and County of San Francisco currently imposes a tax on the payroll expense of persons who conduct business in the City. The tax is levied at a rate of 1.5 percent against a business's taxable payroll expense, which includes all compensation a person pays to individuals for services performed in the City. The City exempts small businesses with less than \$250,000 in payroll expense.

### Amendments to Current Law

The legislation phases in a gross receipts tax gradually, over a five-year period that commences with tax year 2014. The phase-in period allows businesses time to adjust to the gross receipts tax. It also minimizes risk of revenue uncertainty to the City, and to business taxpayers as a whole. Also beginning in tax year 2014, the payroll expense tax will be phased out in increments consistent with the phase in of the gross receipts tax, and is expected to be phased out completely in tax year 2018. If the gross receipts tax generates revenue in excess of that expected during the phase-in process, the payroll expense tax will be phased out early and final gross receipts tax rates will be permanently established at less than the maximum rates authorized by this Ordinance. If, on the other hand, gross receipts tax revenues are less than expected, then the payroll expense tax will not be fully phased out, and a reduced payroll expense tax rate will remain at the end of the process. Beginning tax year 2014, a business whose predominant activity in the City is providing administrative services for itself or a related

entity will continue to pay a tax based on its payroll expense instead of on its gross receipts. All tax proceeds would be deposited in the General Fund and could be expended for any purpose of the City.

Section 2 provides that the Ordinance that will be submitted to qualified electors at the November 6, 2012 general election.

Section 3 enacts new Article 12-A-1, the Gross Receipts Tax Ordinance, as specified. The proposed Gross Receipts Tax Ordinance would impose a tax for the privilege of engaging in a business in the City that is measured by the taxpayer's gross receipts or from business activities that are attributable to the City. The rate of the gross receipts tax is dependent upon a business's activities and the rates are progressive within each industry group. A business predominantly engaged in the City in providing administrative services for itself or a related entity pays a fixed rate of tax measured by its payroll expense. Businesses with less than \$1 million in gross receipts are exempt from the gross receipts tax. The gross receipts tax is to be phased in over a five-year period and during that period, the City's payroll expense tax will be phased out. The value of certain exclusions under the current payroll expense tax are carried forward into the gross receipts tax.

Section 4 provides that all sections of this Ordinance are operative beginning tax year 2014, except for the amendments to the Business Registration Ordinance, which are operative on the effective date of this Ordinance.

Section 5 amends the Business Registration Ordinance under Article 12 to establish business registration fees for 2014-2015 based on payroll expense and to establish business registration fees for registration years beginning after June 30, 2015 based on gross receipts to generate an additional \$13 million in revenue. It also amends current business registration fees to add a penalty for failure to register business locations and fictitious business names with the Tax Collector, and to add a new fee for registering more than 15 fictitious business names.

Section 6 amends the Payroll Expense Tax Ordinance under Article 12-A to conform the payroll expense tax rates to the phase in of the Gross Receipts Tax Ordinance and provide a sunset date for the existing surplus business tax revenue credit.

Section 7 amends the Common Administrative Provisions set forth in Article 6 of the Business and Tax Regulations Code. The amendments to Article 6 amend return and payment requirements and otherwise conform the administrative provisions to the provisions of the Gross Receipts Tax Ordinance and the amendments to the Payroll Expense Tax Ordinance.

Section 8 provides that the effective date of this legislation is 10 days after the date the official vote count is declared by the Board of Supervisors.

Background Information

San Francisco is the only major city in California that levies its entire business tax on payroll expense. This payroll-based tax raises an affected business's cost of hiring a worker in San Francisco, and thereby discourages job creation. Instituting a tiered rate structure under which a business is taxed based on its gross receipts will better distribute the tax burden among the City's businesses.

A gross receipts tax is the most common business tax base among California's largest cities. Replacing the payroll expense tax in San Francisco can be expected to stimulate employment in the City, as well as broadening and stabilizing the tax base.

On Monday, June 25 2012, the Small Business Commission (SBC) held a hearing on Board of Supervisors  
File No's 120681 and 120682, Board Motions proposing to submit and ordinance to phase out the City's  
Payroll Tax and implement a Gross Receipts based business tax.

The SBC voted 5-0 to provide the following policy recommendations to the Mayor and Board of  
Supervisors. The gross receipts tax structure is more equitable and will more fairly distribute the business  
tax among payers. The Commission did not recommend approval of one ordinance over the other; rather,  
the Commission encourages the Mayor and Board of Supervisors to work collaboratively on submitting a  
single, consensus ordinance to the voters.

The Commission, in its 5-0 vote, made two affirmative recommendations to be retained in the final  
ordinance:

1. Maintain the under \$1 million small business gross receipt exemption.
2. Continue existing tax exclusions, including the Local Enterprise Zone, Bio Tech, Clean Tech and  
Central Market designations should be maintained and transitioned into the gross receipts structure, as  
proposed by the Mayor/Chiu ordinance. Maintaining the Local Enterprise Zone is very important to the  
SBC, as it has stimulated economic growth in some of the City's most disadvantaged neighborhoods. The  
Central Market exclusions are set to expire April 20, 2019 less than a year after the completions of the five  
year phase in/out period.

The Commission supports the increased level of tiers for the business license registration fee and the tier  
structure of the gross receipts tax. Regarding the business license registration fee, the Commission  
supports the setting of amounts not to exceed those specified in the Mayor/Chiu proposal for businesses  
generating less than \$25 million in revenue. In excess of \$25 million in revenue, the Commission  
considers the final amounts determined to be policy decisions for the Mayor and Board of Supervisors.

The Commission supports revenue generation to fund the housing trust fund. Commissioners recognize  
the linkage between the benefits of a workforce that can afford to live in the City and finds that this  
provision is warranted.

The Commission recognizes that in order for the two proposals to come together, additional revenue generation is likely. The Commission will support this direction, with the provision that a commitment be made by the Mayor and Board of Supervisors for additional revenue generated to be committed to programs and projects that have a tangible benefit to the business community. The Commission recommends that an additional \$700,000 per year be raised to provide additional funding to the Office of Small Business. The Commission did not specify a revenue generation dollar amount above the \$700,000 allotted to the office of Small Business and considers this a policy decision for the Mayor and Board. The Commission finds that infrastructure projects such as roads and sidewalks, commercial corridor improvements, transit improvements, public safety programs and affordable housing projects all benefit the business community in addition to the City as a whole and should be prioritized.

Again, the SBC recommends, within the parameters set above, that the Mayor and Board of Supervisors work together to craft a single consensus measure to be presented to the voters. The Commission requests that the business community, both small and large continue to be stakeholders in this process and be included in discussions, especially those pertaining to revenue generation.
