21 Section 1. Chapter 16, Article I, of the San Francisco Administrative Code is hereby
 22 amended by amending Section 16.6, to read as follows:

1 **REPORT OF MEMBERSHIPS TO THE MAYOR, CONTROLLER AND BOARD OF**
2 **SUPERVISORS.**

3 City departments and their duly authorized officers and employees may acquire and
4 maintain membership in professional, trade and other organizations, where such membership
5 is in the interest and for the benefit of the City and County, as follows:

6 ((In the interest and for the benefit of the City and County, the following departments
7 and their duly authorized officers and employees are hereby authorized to acquire and
8 maintain membership in organizations as hereinafter designated, and to represent the City
9 and County in such organizations.))

10 By May 1st of each year, each board, commission and department head of the City
11 and County shall submit to the Mayor, the Controller, and the Board of Supervisors ((:

12 1. A listing of each and every organization of which the board, commission or
13 department is a member, the cost, if any, for the City to belong to each of the listed
14 organizations, and a statement as to whether the cost for each membership is included in
15 their current fiscal year budget as approved by the Board of Supervisors.

16 2. A listing for the fiscal year in which the report is being prepared of each and every
17 organization in which the board, commission or department's membership has been approved
18 by the Board of Supervisors.

19 3. A)) a listing for the next fiscal year of each and every organization in which the
20 board, commission or department wishes to be a member, including a listing of the
21 membership cost for each organization in which membership will be sought. The listing shall
22 also specify which organizations have been added to or deleted from the previous year's list.
23 The proposed memberships shall be deemed approved unless specifically disapproved by
24 resolution of the Board of Supervisors introduced within 60 days of submission of the
25 department's list.

1 that the Mayor or the Mayor's designee may authorize attendance at meetings in California
2 when funds are certified by the Controller as being legally available for such purposes within
3 the publicity and advertising fund.

4
5 **SEC. 16.6-2 ((16.6-49)). REPRESENTATION OF CITY AND COUNTY IN CERTAIN**
6 **ORGANIZATIONS — REPRESENTATIVES AT MEETINGS — VOTING CONTRARY TO**
7 **CITY POLICY.** No officer or employee authorized to attend a meeting or convention by the
8 Board of Supervisors shall cast a vote or make any representation at such meeting or
9 convention, while acting or purporting to act as a representative of the City and County, which
10 he knows to be contrary to or in conflict with any officially established policy of the City and
11 County on the subject matter of the vote or representation.

12 “Officially established policy” shall mean a policy established by ordinance, resolution
13 or other written document constituting a public record, made, enacted or adopted by the
14 board or officer having legal jurisdiction to establish such policy for the City and County.

15 Violation of this Section shall be deemed an act of official misconduct or
16 insubordination and shall subject the violator to the proceedings and the penalties therefor
17 provided by the Charter or other applicable law.

18
19 **SEC. 16.6-3 ((16.6-49.1)). MEMBER OF BOARD OF SUPERVISORS SERVING ON**
20 **INTERGOVERNMENTAL BODY — DUTIES.** The Board of Supervisors of the City and
21 County of San Francisco does hereby assume the position that all intergovernmental bodies,
22 decision-making boards, organizations and groups on which a member of the San Francisco
23 Board of Supervisors sits shall provide a channel for public comment in the form of a citizens
24 advisory committee; or in the case that a body is charged with the operation of an existing
25 physical property, shall provide for regular public hearings to accept comment on the

1 performance of that body.

2
3 **SEC. 16.6-4 ((16.6-49.2)). MEMBER OF BOARD OF SUPERVISORS SERVING ON**
4 **INTERGOVERNMENTAL BODY — PROGRAM OF PUBLIC HEARING.** Should a member of
5 the board presently sit with such a group he will forthwith exert all effort to assist the formation
6 of a citizens advisory committee or commence a regular program of public hearing.

7
8 **SEC. 16.6-5 ((16.6-49.3)). MEMBER OF BOARD OF SUPERVISORS SERVING ON**
9 **INTERGOVERNMENTAL BODY — ESTABLISHMENT OF CITIZENS ADVISORY**
10 **COMMITTEE.** It is the policy of the San Francisco Board of Supervisors that in a new body,
11 the supervisor appointed thereto must work toward the establishment of a citizens advisory
12 committee in the body's bylaws.

13
14 **SEC. 16.6-6 ((16.6-51)). MEMBER OF BOARD OF SUPERVISORS SERVING ON**
15 **INTERGOVERNMENTAL BODY — ASSESSOR.** The Assessor is hereby authorized to
16 accept appointment as a member of the Tax Advisory Committee of the County Supervisors
17 Association of California and the Legislative and Executive Committee of the Association of
18 County Assessors.

19 The Assessor, or the Assessor's duly authorized representative, is hereby authorized
20 to attend meetings of the Tax Advisory Committee of the County Supervisors Association of
21 California, and the Legislative and Executive Committee of the Association of County
22 Assessors, provided that funds have been specifically appropriated for such purpose.

23 The Assessor or his duly authorized representatives, or both, are hereby authorized to
24 attend meetings of the California State Legislature or its committees, the State Board of
25 Equalization, and the Bay Area Conference of Assessors; provided, that funds have been

1 specifically appropriated for such purpose.

2
3 **SEC. 16.6-7 ((16.6-53)). JUVENILE COURT EMPLOYEES TO ATTEND SOCIAL**
4 **SERVICES CERTIFICATE PROGRAM.** The Board of Supervisors finds and determines that
5 it is for the interest and benefit of the City and County of San Francisco that officers and
6 employees of the Juvenile Court enroll in, attend and complete a certificate program in the
7 social services conducted by the University of California through its Graduate School of
8 Social Welfare and its Extension Division, the said program consisting of courses offered on
9 evenings plus a concluding two-week residence seminar on the campus at the University of
10 California.

11 The Chief Probation Officer of the Juvenile Court of the City and County of San
12 Francisco is hereby authorized to assign officers and employees under his jurisdiction to
13 attendance at the two-week residence seminar of the University of California certificate
14 program in social services, provided such officers and employees have completed the
15 prerequisite courses and will receive their certificates in social services upon the satisfactory
16 completion of the residence seminar and provided, further, that such officers and employees
17 shall meet their own expenses incident to attendance at the residence seminar.

18
19 **SEC. 16.6-8 ((16.6-54)). CITIZENS ADVISORY COMMISSION FOR**
20 **CONSTITUTIONAL REVISION.** The Board of Supervisors finds and determines that it is for
21 the interest and benefit of the City and County of San Francisco that officers and employees
22 of the City and County accept appointment to the Citizens Advisory Commission for
23 Constitutional Revision, which commission analyzes, considers and recommends revisions to
24 constitutional provisions, many of which affect the conduct of City and County government.

25 Appointing officers are accordingly authorized to permit City and County officers and

1 employees under their jurisdiction who are members of the Citizens Advisory Commission for
2 Constitutional Revision to attend meetings of such commission during normal work hours of
3 such officers and employees.

4
5 **SEC. 16.6-9 ((16.6-55)). HUMAN RIGHTS EMPLOYEES TO ATTEND CERTAIN**
6 **CONFERENCES, WORKSHOPS, SEMINARS, AND TRAINING COURSES.** The Human
7 Rights Commission is authorized to assign commission members, its director, and, upon
8 recommendation of its director, employees of the Human Rights Commission to attend certain
9 conferences, workshops, seminars and training courses sponsored by other public agencies,
10 employers, labor unions, property owners associations, realtor associations, religious
11 denominations and institutions, professional associations, national origin groups, community
12 organizations, social welfare organizations and such other private organizations and
13 institutions concerned with interracial, interreligious and intercultural understanding.

14 The Controller of the City and County of San Francisco is hereby authorized to
15 reimburse commissioners and employees for expenses incurred while attending such
16 conferences, workshops, seminars and training courses, provided funds have been
17 appropriated for such purpose.

18
19 **SEC. 16.6-10 ((16.6-56)). ASSESSOR'S OFFICE EMPLOYEES TO ATTEND**
20 **TRAINING COURSES ON ASSESSMENT PRACTICES.** The Assessor of the City and
21 County of San Francisco is authorized to assign employees of the Assessor's office to attend
22 training courses on assessment practices and procedures sponsored by the Division of
23 Assessment Standards of the State Board of Equalization at universities or colleges located
24 within the State of California.

25 The Controller of the City and County of San Francisco is hereby authorized to

1 reimburse employees for expenses incurred while attending such training courses, provided
2 funds have been appropriated for such purpose.

3
4 **SEC. 16.6-11 ((16.6-57)). MEMBERSHIP OF DIRECTOR OF PUBLIC WORKS IN**
5 **TOPICS.** The Director of Public Works of the City and County of San Francisco, be and he is
6 authorized and directed and appointed to serve as the official representative of the City and
7 County of San Francisco to assist the State Department of Public Works in the administration
8 of the Federal TOPICS (Traffic Operations Program to Increase Capacity and Safety)
9 program within the boundaries of said City and County.

10
11 **SEC. 16.6-12 ((16.6-58)). TRAFFIC ENGINEERING IMPROVEMENTS —**
12 **FORMULATION BY DIRECTOR OF PUBLIC WORKS.** The Director of Public Works is
13 authorized to formulate traffic engineering improvements designed to reduce congestion and
14 improve traffic flow on a system of urban streets pursuant to the intent of the TOPICS
15 program and subject to approval by the Board of Supervisors of the City and County of San
16 Francisco.




