12	Epicurean Trader, located at One Ferry Building (District 3); and
13	WHEREAS, The Planning Department has verified that the area is properly
14	zoned and recommends approval; and
15	WHEREAS, The Police Department has filed zero protests and zero letters of
16	support with the Department of Alcoholic Beverage Control under California Business
17	and Professions Code, Section 24013, and recommends that the Department of
18	Alcoholic Beverage Control issue the liquor license with conditions; and
19	WHEREAS, The conditions recommended by the Police Department are the
20	following: 1) When tasting is being conducted, there shall be signs in a conspicuous
21	space at the entrance and/or exits of the premise as depicted on the ABC-257, which
22	will state "NO ALCOHOLIC BEVERAGES BEYOND THIS POINT." Said signs shall be
23	no less than 7" X 11" in size and contain lettering no less 1" in height; and 2) Signs shall
24	be posted that "No minors are allowed in the tasting area;" now, therefore, be it
