3 **Resolution authorizing the Chief of Police for the City and County of San Francisco to**  
4 **accept and expend grant funds made available through the California Office of Traffic**  
5 **Safety (OTS) for a project entitled "You Drink & Drive. You Lose" national campaign.**

7 WHEREAS, The goal of the Sobriety Checkpoint Program is to reduce the number of  
8 victims killed and injured in alcohol involved crashes; and,

9 WHEREAS, The San Francisco Police Department will conduct sobriety checkpoints  
10 during a 17 day period in December 2003 - January 2004, and a 16 day period in June -  
11 July 2004, in support of the "You Drink & Drive. You Lose" national campaign; and,

12 WHEREAS, Whereas, The grant terms prohibit including indirect costs in the grant  
13 budget; now, therefore, be it

14 RESOLVED, That the Board of Supervisors hereby waives inclusion of indirect costs in  
15 the grant budget; and be it

16 FURTHER RESOLVED, That the Chief of Police of the City and County of San  
17 Francisco is authorized on behalf of the City and County of San Francisco to retroactively  
18 accept and expend continued funding for this project from the Office of Traffic Safety; and be  
19 it

20 FURTHER RESOLVED, That the Chief of Police is authorized to execute on behalf of  
21 the City and County of San Francisco the necessary grant award agreement for this project  
22 including any extensions, funding augmentations from OTS, or amendments thereof; and be it



6 supplant expenditures controlled by the City and County of San Francisco.




