2 **SUPPORTING THE "WORKING TOGETHER TO STOP THE HATE VIOLENCE"**
3 **CAMPAIGN AND THE MANY COMMUNITY GROUP WORKING COLLABORATIVELY TO**
4 **PROMOTE POSITIVE INTERGROUP RELATIONS IN SAN FRANCISCO.**

5 WHEREAS, In response to the expanding demand to identify resources and information
6 for victims of hate crimes and hate violence incidents, a hate violence prevention campaign
7 will be launched on February 24, 2000; and,

8 WHEREAS, Community leaders, educators, advocates and faith leaders/clergy alike
9 have come together from all over the city to fight against hate violence; and

10 WHEREAS, The organizers of the campaign represent a broad cross-section of the city
11 and include: Asian Law Caucus, Booker T. Washington Community Services Center,
12 Community United Against Violence, Filipinos for Affirmative Action, Intergroup Clearinghouse,
13 Islamic Center of S.F., S.F. Jewish Community Center, Jewish Community Relations Council,
14 KQED, Mexican American Legal Defense and Education Fund, No. Cal. Coalition for
15 Immigrant Rights, S.F. SAFE, S.F. SAFE, S.F. Neighborhood Safety Partnership, Safety
16 Network, SFPD Hate Crimes Unit, Television Race Initiative, Sunset Youth Services, and the
17 U.S. Department of Justice/Community Relations Services; and,

18 WHEREAS, During the previous year, the targets of hate violence included the
19 murders of two gay men in Redding, the fire bombing of three synagogues in Sacramento, the
20 murder of a postal worker in Los Angeles and the distribution of hate filled flyers in San
21 Francisco; and,

22 WHEREAS, Stopping the hate begins with recognizing the problem, and joining
23 together in a shared effort that responds to and prevents such acts of hatred; and

24 WHEREAS, The San Francisco "Working to Stop Hate Violence" highlights the
25 activities and actions of many different organization working together to create alternatives to

1 the fear and intimidation communities often experience when targeted by hate violence; now,
2 therefore, be it

3 RESOLVED, That the Board of Supervisors of the City and County of San Francisco

5 FURTHER RESOLVED, That the Board of Supervisors of the City and County of San
6 Francisco declares February 24, 2000 to be "Stop Hate Violence" Day.
