3 **Ordinance authorizing settlement of the lawsuit filed by Alison Jordan Llamas against**  
4 **the City and County of San Francisco for \$30,000; the lawsuit was filed on July 15,**  
5 **2024, in San Francisco Superior Court, Case No. CGC-24-616420; entitled Alison**  
6 **Jordan Llamas v. City of San Francisco, et al.; the lawsuit involves alleged property**  
7 **damage and personal injuries arising from a vehicle collision.**

9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby  
11 authorizes the City Attorney to settle the action entitled Alison Jordan Llamas v. City of San  
12 Francisco, et al., San Francisco County Superior Court, Case No. CGC-24-616420 by the  
13 payment of \$30,000. The lawsuit involves alleged property damage and personal injuries  
14 arising from a vehicle collision.

15 Section 2. The above-named action was filed in San Francisco Superior Court on July  
16 15, 2024, and the following parties were named in the lawsuit: Plaintiff Alison Jordan Llamas;  
17 Defendants: City of San Francisco, County of San Francisco, and Jeremy Lobo.
