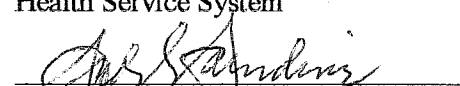
Section 1. The San Francisco Administrative Code is hereby amended by amending Section
16.157 to read as follows:

Section 16.157. HEALTH SERVICE SYSTEM: PLAN AND CONTRIBUTION RATES.
Changes in contribution rates adopted by the Health Service Board, as respects the plans of the Health
Service System, to become effective on July 1, ((1998)) 1999 for the fiscal year July 1, ((1998)) 1999
through June 30, ((1999)) 2000 approved by the Health Service Board in actions taken by it on
((February 26, 1998)) March 11, 1999, which plans and contribution rates are on file with the Clerk of the
Board of Supervisors, are hereby approved.

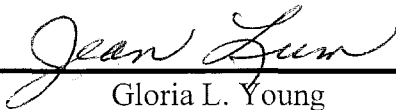
