8 WHEREAS, The Chief of Police of the City and County of San Francisco desires to  
9 accept, install, staff, utilize and maintain a telephone intercept system from resources made  
10 available in part through the Technology Transfer Program, Office of National Drug Control  
11 Policy, Counterdrug Technology Assessment Center (ONDCP/CTAC); and,

12 WHEREAS, The utilization of this counterdrug technology equipment will provide  
13 material evidence to greatly assist law enforcement efforts to disrupt the drug markets and  
14 associated homicides; now, therefore, be it

16 RESOLVED, That the Chief of Police of the City and County of San Francisco is  
17 authorized on behalf of the City and County of San Francisco to retroactively accept, install,  
18 staff, utilize and maintain this project from the ONDCP/CTAC office; and be it

20 FURTHER RESOLVED, That The Chief of Police of the City and County of San  
21 Francisco is authorized to execute on behalf of the City and County of San Francisco the  
22 necessary coordination and infrastructure improvements required to house the equipment for  
23 this project including any other equipment transfers required or augmentations from the  
24 ONDCP/CTAC office thereof; and be it






