

1 [Accept and Expend Grant – Enhancing Pre-Exposure Prophylaxis in Community Setting -
2 \$21,262]

3 **Resolution authorizing the San Francisco Department of Public Health to retroactively**
4 **accept and expend a Federal Pass-Through Private grant in the amount of \$21,262**
5 **from Public Health Foundation Enterprises, Inc., to participate in a program entitled**
6 **‘Enhancing Pre-Exposure Prophylaxis in Community Setting’ for the period of October 1,**
7 **2011, through June 30, 2012.**

9 WHEREAS, Public Health Foundation Enterprise, Inc. (PHFE) is the recipient of a grant
10 award from the National Institute of Health supporting the Enhancing Pre-Exposure
11 Prophylaxis in Community Setting; and

12 WHEREAS, With a portion of these funds, PHFE has subcontracted with San
13 Francisco Department of Public Health (DPH) in the amount of \$21,262 for the period of
14 October 1, 2011, through June 30, 2012; and

15 WHEREAS, As a condition of receiving the grant funds, PHFE requires the City to
16 enter into an agreement (Agreement), a copy of which is on file with the Clerk of the Board of
17 Supervisors in File No. 120207; which is hereby declared to be a part of this
18 Resolution as if set forth fully herein; and

19 WHEREAS, The purpose of this project is to oversee the creation of study plans for
20 enhancing pre-exposure prophylaxis in community setting and draft study related materials
21 including data collection forms; and

22 WHEREAS, An Annual Salary Ordinance amendment is not required as the grant
23 partially reimburses DPH for one existing position, one Senior Physician Specialist (Job Class
24 No. 2232) at .10 FTE for the period of October 1, 2011, through June 30, 2012; and

1 WHEREAS, A request for retroactive approval is being sought because DPH did not
2 receive notification of the award until December 13, 2011 for a project start date of October 1,
3 2011; and,

4 WHEREAS, The budget includes a provision for indirect costs in the amount of \$3,411;
5 now, therefore, be it

6 RESOLVED, That DPH is hereby authorized to accept and expend a grant retroactively
7 in the amount of \$21,262 from PHFE; and, be it

8 FURTHER RESOLVED, That DPH is hereby authorized to retroactively accept and
9 expend the grant funds pursuant to San Francisco Administrative Code section 10.170-1; and,
10 be it

11 FURTHER RESOLVED, That the Director of Health is authorized to enter into the
12 agreement on behalf of the City.




