2 RESOLUTION DETERMINING THAT THE TRANSFER OF A TYPE 20 OFF-SALE
3 BEER AND WINE ALCOHOLIC BEVERAGE CONTROL LICENSE FROM 1401
4 CLEMENT STREET TO 599 CLEMENT STREET TO DANIEL P. KAHN FOR
5 COMPETITION CLOSE OUTS WILL SERVE THE PUBLIC CONVENIENCE AND
6 NECESSITY OF THE PEOPLE OF THE CITY AND COUNTY OF SAN FRANCISCO,
7 IN ACCORDANCE WITH SECTION 23958.4 OF THE CALIFORNIA BUSINESS AND
8 PROFESSIONS CODE. WITH CONDITIONS.

10 WHEREAS, Daniel P. Kahn is seeking transfer of a Type 20 off-sale beer and
11 wine alcoholic beverage control license for Competition Close Outs located at 599
12 Clement Street; and,

13 WHEREAS, The City Planning Department has verified that the area is properly
14 zoned; and,

15 WHEREAS, The Police Department recommends that the liquor license
16 application be approved with conditions; now, therefore, be it

17 RESOLVED, That in accordance with Section 23958.4 of the California Business
18 and Professions Code, the Board of Supervisors of the City and County of San
19 Francisco hereby determines for the foregoing reasons that the transfer of a Type 20
20 off-sale beer and wine alcoholic beverage control license from 1401 Clement Street to
21 599 Clement Street for Daniel P. Kahn for Competition Close Outs, will serve the public
22 convenience and necessity of the people of the City and County of San Francisco.

23 Conditions: 1) Sales and delivery of alcoholic beverages shall be permitted only
24 between the hours of 10:00 a.m. and 6 p.m. each day of the week. 2) The petitioner
25 shall be responsible for maintaining free of litter the area in front of and adjacent to the

1 premises over which they have control. 3) No wine shall be sold with an alcoholic
2 content greater than 15% by volume. 4) Wine shall not be sold in bottles or containers
3 smaller than 750 ml, and wine coolers shall not be sold in units of less than a four pack.
4 5) No person under the age of 21 shall sell or package alcoholic beverages. 6) No
5 more than 5% of the square footage of the premises will be used for the sale of
6 alcoholic beverages. 7) No alcoholic beverage will be sold ready for consumption
7 (chilled or refrigerated),




