AMENDING ARTICLE 28, PART II, CHAPTER V, OF THE SAN FRANCISCO MUNICIPAL CODE (HEALTH CODE), WHICH AUTHORIZED THE DEPARTMENT OF PUBLIC HEALTH TO ISSUE MEDICAL CANNABIS IDENTIFICATION CARDS, BY AMENDING SECTION 1805 TO FIX RATES FOR IDENTIFICATION CARDS FURNISHED BY THE DEPARTMENT OF PUBLIC HEALTH, EFFECTIVE UPON APPROVAL.

Note: Additions are underlined; deletions are in ((double parenthesis)).

Be it ordained by the People of the City and County of San Francisco:

Article 28, Part II, Chapter V of the San Francisco Municipal Code (Health Code) is hereby amended by amending Section 1805, to read as follows:

**SEC. 1805. FEES.** The Department is authorized to charge every applicant for a medical cannabis user identification card or a primary caregiver identification card a fee sufficient to cover the costs of the medical cannabis user identification and primary caregiver identification cards program. The Department shall consider the extent of an applicant's ability to pay the whole or partial fee and may provide for fee waiver or reduction in appropriate cases.


The Board of Supervisors of the City and County of San Francisco does hereby determine and fix the proper reasonable amounts to be charged to persons seeking medical cannabis identification cards from the Department of Public Health as follows, which rates shall be effective for this service delivered as of the date of approval of this ordinance.




