8 MOVED, That the Board of Supervisors of the City and County of San Francisco does
9 hereby appoint the hereinafter designated persons to serve as members of the Medical
10 Cannabis Task Force, pursuant to the provisions of the San Francisco Administrative Code,
11 Sections 5.2-1 through 5.2-6, for the terms specified:

12 Stephanie Tucker, seat 1, must be a community organizer representative with a
13 background in organizing neighbors, businesses or organizations around social justice and
14 quality of life issues. This representative should also have a background working on medical
15 cannabis related issues, for a two-year term to be determined.

16 David Goldman, seat 2, must be a representative of a local patient advocacy
17 organization with a background in working to protect the interests of medical cannabis
18 patients, for a one-year term to be determined.

19 Shona Gochenhaur, seat 3, must be a representative of a local patient advocacy
20 organization with a background in working to protect the interests of medical cannabis
21 patients, for a two-year term to be determined.

22 Mary Schroeder, seat 4, must be a representative of a hospice or a residential care
23 facility with a background as an employee or volunteer in direct services working with medical
24 cannabis patients or as a nurse or physician with a background in working with or treating of
25 medical cannabis patients, for a one-year term to be determined.

1 Raymond Gamely, seat 5, must be a person with a background in the management of
2 a medical cannabis dispensary, for a two-year term to be determined.

3 Martin Olive, seat 6, must be a person with a background in the management of a
4 medical cannabis dispensary, for a one-year term to be determined.

5 Kevin Reed, seat 7, must be a person with a background in the management of a
6 medical cannabis dispensary whose primary mode of operation is delivery, for a two-year term
7 to be determined.

8 Sarah Shrader, seat 8, must be a representative of a drug policy organization working
9 specifically on medical cannabis issues, for a one-year term to be determined.

10 Patrick Goggin, seat 9, must be a licensed California attorney with a background
11 working with San Francisco medical cannabis dispensaries and experience with the City's
12 medical cannabis dispensary permitting and regulatory process, for a two-year term to be
13 determined.

14 Albert Blais, seat 10, must be a person with a background in providing medical
15 cannabis to low-income patients, for a one-year term to be determined.

16 Joseph Erich Pearson, seat 11, must be a person with a background in providing
17 medical cannabis to permitted medical cannabis dispensaries located in the City and County,
18 for a two-year term to be determined.

19 Michelle Aldrich, seat 12, must be a person with at least fifteen years of experience
20 working on medical cannabis issues in the City and County, for a one-year term to be
21 determined.

22 Maureen Burns, seat 13, must be a representative of a recognized neighborhood
23 organization that has a medical cannabis dispensary within its boundaries, for a two-year term
24 to be determined.
