3 **Ordinance amending the General Plan to revise Map 1 of the Market and Octavia Area**  
4 **Plan to change the designation of 1650, 1660, 1670 and 1680 Mission Street, Assessor's**  
5 **Parcel Block No. 3512, Lot Nos. 005, 006, 008, 009 and 010, from NC-3 (Moderate Scale**  
6 **Neighborhood Commercial Transit) and P (Public Use District) to C-3-G (Downtown**  
7 **General Commercial District); and making environmental findings, findings of**  
8 **consistency with the General Plan, and the eight priority policies of Planning Code,**  
9 **Section 101.1, and findings of public necessity, convenience and welfare under**  
10 **Planning Code, Section 340.**

14 Be it ordained by the People of the City and County of San Francisco:

15 Section 1. Environmental and Planning Code Findings.

16 (a) California Environmental Quality Act Findings. The Planning Department has  
17 determined that the actions contemplated in this ordinance comply with the California  
18 Environmental Quality Act (California Public Resources Code Sections 21000 et seq.), and  
19 the Board of Supervisors hereby affirms this determination. Said determination is on file with  
20 the Clerk of the Board of Supervisors in File No. 181112 and is incorporated herein by  
21 reference.

23 (b) General Plan and Planning Code Findings.

24 (1) Under Charter Section 4.105 and Planning Code Section 340, any  
25 amendments to the General Plan shall first be considered by the Planning Commission and

1 thereafter recommended for approval or rejection by the Board of Supervisors. On October  
2 25, 2018, by Resolution No. 20326, the Commission conducted a duly noticed public hearing  
3 on the General Plan Amendment pursuant to Planning Code Section 340, and found that the  
4 public necessity, convenience, and general welfare required the proposed General Plan  
5 Amendment, and recommended it for approval to the Board of Supervisors. The Board  
6 adopts these findings as its own. A copy of said resolution is on file with the Clerk of the  
7 Board of Supervisors in File No. 181112, and is incorporated herein by reference.

8 (2) On October 25, 2018, the Planning Commission, in Resolution No. 20326,  
9 adopted findings that the actions contemplated in this ordinance are consistent, on balance,  
10 with the City's General Plan and eight priority policies of Planning Code Section 101.1. The  
11 Board adopts these findings as its own. A copy of said Resolution is on file with the Clerk of  
12 the Board of Supervisors in File No. 181112, and is incorporated herein by reference.

13  
14 Section 2. The San Francisco General Plan is hereby amended by revising Map 1 of  
15 the Market and Octavia Area Plan to change the designation of 1650, 1660, 1670 and 1680  
16 Mission Street, Assessor's Parcel Number No. 3512, Lot Nos. 005, 006, 008, 009, and 010,  
17 as recommended to the Board of Supervisors by the Planning Commission in Resolution No.  
18 20326, as follows:

19 1650, 1660, and 1670 Mission Street (Assessor's Parcel Number No. 3512, lots Nos.  
20 005, 006 and 008, from NC-3 to C-3-G; and


21 1680 Mission Street (Assessor's Parcel Number No. 3512, lots 009 and 010, from P to  
22 C-3-G.

23 The Board of Supervisors directs the Planning Department to update the General Plan  
24 to reflect these amendment.
