3 **Motion amending the Board's Rules of Order to add Rule 2.32, requiring each candidate**  
4 **for a Board, Commission or advisory body appointment or confirmation who would be**  
5 **required to file a Form 700 (Statement of Economic Interests) to submit such a**  
6 **Statement to the Clerk of the Board of Supervisors prior to Board Consideration of the**  
7 **appointment or confirmation, and allowing the Board to consider appointments or**  
8 **confirmations, despite the failure of an applicant to file a completed Form 700, if the**  
9 **time for Board consideration is about to expire.**

14 MOVED, That Rule 2.32 is hereby added to the Rules of Order of the Board of  
15 Supervisors, to read as follows:

16 **RULE 2.32. CERTAIN CANDIDATES FOR COMMISSION APPOINTMENTS MUST**  
17 **SUBMIT A FORM 700 PRIOR TO BOARD CONSIDERATION. Neither the Board of Supervisors,**  
18 **nor any Committee thereof, except as provided below, shall consider the appointment or confirmation**  
19 **of any person whose appointment to a Board, Commission or advisory body is subject to approval or**  
20 **confirmation by the Board of Supervisors, until the person has submitted to the Clerk of the Board of**  
21 **Supervisors a completed Statement of Economic Interests ("Form 700"), if the Form would be required**  
22 **under the California Political Reform Act, Government Code Section 87100, et seq., and San Francisco**  
23 **Campaign and Government Conduct Code Section 3.1.-100, et seq., for the office sought. If the Clerk**  
24 **of the Board determines that an applicant for an appointment may not submit a completed Form 700 in**  
25 **time to allow the Board to consider the appointment prior to the appointment becoming final by**

1 operation of law, then the Clerk shall schedule the consideration of the appointment at the next  
2 available Committee meeting, and shall ask the applicant to submit a completed Form 700 prior to the  
3 Committee's consideration. Applicants who do not submit a completed Form 700 may lack interest in  
4 the position, or may be reluctant to submit a Form 700, even though they will be required to file such a  
5 Form upon appointment or confirmation. It is the policy of the Board that when applicants fail to  
6 submit a completed Form 700, the Board shall reject the appointment or confirmation. The Clerk of  
7 the Board shall notify appointees subject to this requirement that submission of the Form pursuant to  
8 this Rule does not satisfy the requirement to file a completed Form 700 within 30 days of assuming  
9 office.
