Contract Summary

- PeopleSoft Contract ID: 1000032452
- Covered goods: Electrical supplies for all city departments to use.
- Awarded contractor: Rexel USA, Inc. ("Rexel USA"), selected through an Invitation for Bids ("IFB", Sourcing Event ID 0000008573) issued by the Office of Contract Administration (OCA) in January 2024.
- Initial contract not-to-exceed amount and duration: \$26,200,000, commencing on August 1, 2024 and ending on July 31, 2027, with the option to extend the term for four additional years through July 31, 2031.

Background

- Between 2018 and 2023, City departments encumbered approx. \$34.7 million dollars for the procurement of electric supplies (an average \$5.8 million dollars per year).
- The primary users of electrical supplies are the San Francisco Public Utilities Commission ("PUC") and San Francisco International Airport ("AIR").
- The bulk of these purchase (nearly 70%) is associated with Term Contracts established through OCA, making OCA's contracts for electrical supplies essential to maintaining City operations.

Sourcing Event 0000008573

- OCA issued an Invitation for Bids on January 12,
 2024 under Sourcing Event 0000008573.
- Sourcing Event 0000008573 consisted of three
 Aggregates. Aggregates 1 and 2 were based on all
 items carried by certain named manufacturers.
 Aggregate 3 was for 258 individual products which the
 City uses regularly and frequently.
- Awards were based on a Bidder meeting the Minimum Qualifications and being the lowest responsive Bidder based on price.
- Rexel USA was deemed the lowest responsive Bidder for all three Aggregates.

Contract Pricing Structure

- Aggregates 1 and 2: Award based on the Bidder(s)
 offering the greatest discount off of the Manufacturer
 List Price ("MLP").
 - Rexel's discounts off of MLP for the manufacturers identified in Aggregate 1 range from 8% to 73%.
 - Rexel's discounts off of MLP for the manufacturers identified in Aggregate 2 range from 10% to 85%.
- Aggregate 3: Award based on specific pricing for 258 individual items. Pricing for these items can be adjusted annually.

Conclusion

- OCA's contracts for electrical supplies essential to maintaining City operations.
- Contract ID 1000032452 with Rexel USA will provide these essential items to City departments for a duration of up to 7 years.
- OCA respectfully requests that the Board approve this contract to allow City departments (and particularly PUC and SFO) to continue procuring electrical supplies, thereby ensuring uninterrupted continuation of their operations.
