2 RESOLUTION DISAPPROVING THE REQUEST FOR THE ISSUANCE OF A TYPE 20
3 OFF-SALE BEER AND WINE ALCOHOLIC BEVERAGE CONTROL LICENSE FOR
4 MUEEN ISSA GHANMA AND KHALED ISSA GHANMA FOR ALL STATES BEST
5 FOODS AT 1607-20TH STREET; AND DETERMINING THAT IT WILL NOT SERVE
6 THE PUBLIC CONVENIENCE AND NECESSITY OF THE PEOPLE OF THE CITY
7 AND COUNTY OF SAN FRANCISCO, IN ACCORDANCE WITH SECTION 23958.4 OF
8 THE CALIFORNIA BUSINESS AND PROFESSIONS CODE.

10 WHEREAS, Mueen Issa Ghanma and Khaled Issa Ghanma are seeking the
11 issuance of a type 20 off-sale beer and wine alcoholic beverage control license, for All
12 States Best Foods at 1607 20th Street; and,

13 WHEREAS, The Police Department reports that they received 461 letters against
14 and 369 letters in support of the liquor license; and

15 WHEREAS, The Police Department recommends that due to the number of
16 people in protest of this request because of an over-concentration of liquor licenses in
17 the neighborhood, the liquor license application should be denied; now, therefore, be it

18 RESOLVED, That in accordance with Section 23958.4 of the California Business
19 and Professions Code, the Board of Supervisors of the City and County of San
20 Francisco hereby determines that the issuance of a type 20 off-sale beer and wine
21 alcoholic beverage control license, for All States Best Foods at 1607 20th Street
22 requested by Mueen Issa Ghanma and Khaled Issa Ghanma be denied.

23 FURTHER RESOLVED, That the Board of Supervisors respectfully requests that
24 the Department of Alcoholic Beverage Control deny this application.
