15 decision of Public Works; and

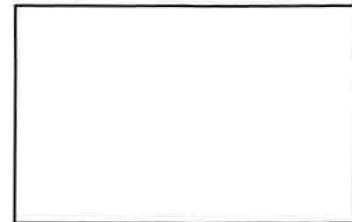
16 WHEREAS, On February 3, 2026, this Board held a duly noticed public hearing to
