9 WHEREAS, Wendy Ai-Phi Van is seeking issuance of a Type 21 off-sale general  
10 license for D & M Liquor Mart, located at 4715 Geary Boulevard; and,

11 WHEREAS, The City Planning Department has verified that the area is properly  
12 zoned; and

13 WHEREAS, The Police Department recommends that the liquor license  
14 application be approved with conditions; now, therefore, be it

15 RESOLVED, That in accordance with Section 23958.4 of the California Business  
16 and Professions Code, the Board of Supervisors of the City and County of San  
17 Francisco hereby determines for the foregoing reasons that the issuance of a Type 21  
18 off-sale general license, to Wendy Ai-Phi Van for D & M Liquor Mart, located at 4715  
19 Geary Boulevard will serve the public convenience and necessity of the people of the  
20 City and County of San Francisco.

21 Conditions: (1) Petitioners shall not permit their patrons or the general public to  
22 loiter or congregate on the sidewalks adjacent to the licensed premises; (2) The  
23 petitioners(s) shall be responsible for maintaining free of litter the area adjacent to the  
24 premises over which they have control; (3) Sales of alcoholic beverages shall be

1 permitted only between the hours of 9:00 a.m. to 12:00 a.m. Sunday through Thursday  
2 and 9:00 a.m. to 2:00 a.m. Friday and Saturdays.




