WHEREAS, Hollister Avenue is where the energetic, selfless, compassionate, and hardworking Bryan Craig Kelley, a 30-year-old, and his family have lived for over four decades; and

WHEREAS, Bryan Kelley was a positive and motivating individual with a magnetic personality; and

WHEREAS, Bryan Kelley excelled in any area he found of interest; and

WHEREAS, Bryan Kelley believed in teamwork, as demonstrated by his compassionate and selfless character while counseling young boys as part of the San Francisco Brown Bombers football program; and

WHEREAS, Bryan Kelley embraced leadership roles both at work and at home, always guided by his strong sense of community; and

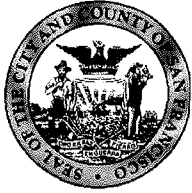
WHEREAS, Bryan Kelley took pride in being a steward for his community; and

WHEREAS, Bryan Kelley volunteered at recreation centers and organized coat drives, personally purchasing coats and keeping them in his car to distribute to those in need; and

WHEREAS, Bryan Kelley was a law-abiding citizen throughout his life, tragically killed in a case of mistaken identity in a freeway drive-by shooting; now, therefore, be it

1 RESOLVED, That in order to publicly recognize the legacy of Bryan Craig Kelley, there
2 shall be an honorary naming of "Bryan Craig Kelley Way" on Hollister Avenue between
3 Jennings Street and Ingalls Street, to enshrine his legacy and honor his profound impact on
4 the community that helped shape his magnanimous character; and, be it

5 FURTHER RESOLVED, That the Department of Public Works is hereby directed to
6 add the honorary street name to its official list of Commemorative Street Names, in
7 accordance with Public Works Code, Sections 789 et seq.
