Conditions: (1) Anytime the premises are providing entertainment or dancing, licensee shall provide uniformed security guards inside and outside premises, including the adjacent west parking lot, until one hour after closing and shall maintain order therein; (2) Petitioner shall regularly police the area under their control in an effort to prevent the loitering of persons about the premises; (3) The petitioner shall be responsible for maintaining free of litter the area adjacent to the premises over which they have control; (4) The sale of alcoholic beverages for consumption off the premises is strictly prohibited; (5) Entertainment provided shall not be audible beyond the area under control of the licensee.
