

1 [Liquor License Transfer - 301 5th Street - City Choice Market]

3 **Resolution determining that the person-to-person, premise-to-premise transfer of**  
4 **a Type-21 off-sale general beer, wine, and distilled spirits liquor license to City**  
5 **Choice Market Inc., doing business as City Choice Market, located at 301 5th**  
6 **Street (District 6), will serve the public convenience or necessity of the City and**  
7 **County of San Francisco, in accordance with California Business and**  
8 **Professions Code, Section 23958.4; and requesting that the California Department**  
9 **of Alcoholic Beverage Control impose conditions on the issuance of the license.**

11 WHEREAS, City Choice Market Inc., is seeking the person-to-person, premise-  
12 to-premise transfer of a Type-21 off-sale general beer, wine, and distilled spirits liquor  
13 license to do business as City Choice Market, located at 301 5th Street (District 6); and

14 WHEREAS, The Planning Department has verified that the area is properly  
15 zoned and recommends approval; and

16 WHEREAS, The Police Department has filed zero protests and zero letters of  
17 support with the Department of Alcoholic Beverage Control under California Business  
18 and Professions Code, Section 24013, and recommends that the Department of  
19 Alcoholic Beverage Control issue the liquor license with conditions; and

20 WHEREAS, The conditions recommended by the Police Department are the  
21 following: 1) Petitioner(s) shall actively monitor the area under their control in an effort to  
22 prevent the loitering of persons on any property adjacent to the licensed premises as  
23 depicted on the ABC-253; and 2) The petitioner(s) shall be responsible for maintaining  
24 free of litter, the area adjacent to the premises over which they have control, as  
25 depicted on ABC-253 now, therefore, be it

1           RESOLVED, That in accordance with California Business and Professions Code,  
2 Section 23958.4, the Board of Supervisors of the City and County of San Francisco  
3 hereby determines that the person-to-person, premise-to-premise transfer of a Type-21  
4 off-sale general beer, wine, and distilled spirits liquor license to City Choice Market Inc.,  
5 doing business as City Choice Market, located at 301 5th Street, will serve the public  
6 convenience or necessity of the City and County of San Francisco; and, be it

7           FURTHER RESOLVED, That the Board of Supervisors of the City and County of  
8 San Francisco hereby endorses and adopts the recommendations of the Police  
9 Department listed above and recommends that the Department of Alcoholic Beverage  
10 Control issue the license with those conditions.
