

1 [Sewer Emergency]

2 **APPROVING THE EXPENDITURE OF FUNDS FOR THE EMERGENCY WORK TO**
3 **REPLACE THE STRUCTURALLY INADEQUATE BRICK SEWER ON PINE STREET**
4 **FROM MONTGOMERY STREET TO SANSOME STREET.**

5 **WHEREAS**, On June 8, 1998, PUC Sewer Operations identified an emergency condition on
6 Pine Street from Montgomery Street to Sansome Street; and

7 **WHEREAS**, The existing sewer had multiple cracks and collapsed sections, and immediate
8 repairs were required in order to protect the health, welfare, and property of the Citizens of San
9 Francisco; and

10 **WHEREAS**, DPW's Bureau of Engineering prepared the Plans and Specifications for Contract
11 No. CW-188E, "Pine Street Emergency Sewer Replacement" to replace the existing 3'x5' brick sewer on
12 Pine Street from Montgomery Street; and

13 **WHEREAS**, The Contractor, JMB Construction, began the emergency work on June 22, 1998
14 and completed it on July 29, 1998; and

15 **WHEREAS**, Because this was an emergency contract, HRC subcontracting goals were not
16 established by the HRC Contract Compliance Officer assigned to monitor the Clean Water Repair and
17 Replacement Program; and

18 **WHEREAS**, The cost of the project is estimated to be \$311,921.00, of which \$253,771.00 is for
19 the construction contract. Funds for this project are available from the Repair and Replacement Fund
20 (Fund 5C/CPF/R&R, FAMIS Project No. CENRNR980, Job Order No. 1608N); and

21 **WHEREAS**, The Public Utilities Commission, in accordance with the provisions of Section 6.30
22 of the Administrative Code of the City and County of San Francisco, declared the existence of an
23 emergency; now, therefore, be it

24 **RESOLVED**, That this Board of Supervisors hereby approves the expenditure of funds for the
25 emergency work to replace the structurally inadequate sewer on Pine Street from Montgomery Street to

1 Sansome Street.
