2 ENACTING AND RESCINDING TRAFFIC REGULATIONS ON VARIOUS STREETS.

3 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
4 and the San Francisco Traffic Code, the following regulations governing the movement of  
5 vehicles are hereby enacted or rescinded as designated below:

6 **BICYCLE LANES - ESTABLISH**

7 Folsom Street, eastbound, between Main Street and The Embarcadero

8 **TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH**

9 Dore Street, east side, from Bryant Street to 222 feet southerly (222-foot zone)

10 Dore Street, west side, from Bryant Street to 480 feet southerly (480-foot zone)

11 Walter U. Lum Place, west side, from Clay Street to 72 feet northerly (72-foot zone)

12 Walter U. Lum Place, west side, from Washington Street to 71 feet southerly  
13 (71-foot zone)




