9 Be it ordained by the People of the City and County of San Francisco:

10 Section 1. Findings.

11 The Planning Department has determined that the actions contemplated in this  
 12 Ordinance are in compliance with the California Environmental Quality Act (California Public  
 13 Resources Code sections 21000 et. seq.). Said determination is on file with the Clerk of the  
 14 Board of Supervisors in File No. \_\_\_\_\_ and is incorporated herein by reference.

15 Section 2. The San Francisco Park Code is hereby amended by amending Section  
 16 12.15, to read as follows:

17 **SEC. 12.15. DAY CAMP FEES.**

18 The following fees shall be charged for Recreation and Park Department day camps  
 19 *per week. Half-day camps are half of the amount shown.*
