 3 APPROVING FEES FOR PARKING AT THE KEZAR PARKING LOT IN GOLDEN GATE

6 Be it ordained by the People of the City and County of San Francisco:

7 Section 1. Findings: Pursuant to San Francisco Charter Section 2.109, the Board of
 8 Supervisors is required to approve the following fees and charges. These fees and charges
 9 reflect increases to the fee schedule in effect since September 19, 1991, with the exception of
 10 the fees for lost tickets and validated ticket books, which remain unchanged.

11 Section 2. Article 12 of the San Francisco Park Code is hereby amended by adding
 12 Sections 12.08, to read as follows:

13 **SEC. 12.08 KEZAR PARKING LOT**

14 The following fees shall be charged for parking at the Kezar Parking Lot.






