5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
6 and the San Francisco Traffic Code, the following regulations governing the parking of  
7 vehicles are hereby enacted or rescinded as designated below:

8 **RESIDENTIAL PERMIT PARKING AREA "J" (2-HOUR TIME LIMIT, 8 AM - 5 PM,**  
9 **MONDAY THROUGH FRIDAY) - ESTABLISH**

10 Hillway Avenue, east side, from Carl Street to the north property line of #40 Hillway  
11 Avenue.

12 **PERPENDICULAR (90-DEGREE ANGLE) PARKING - ESTABLISH**

13 Hillway Avenue, east side, between Carl Street and Parnassus Avenue.

14 **PARKING METERS, 1-HR. TIME LIMIT - RESCIND**  
15 **PARKING METERS, 2-HR. TIME LIMIT - ESTABLISH**

16 20th Avenue, parking lot on west side, between Irving Street and Lincoln Way.

18 Categorically exempt from Environmental Review Class  
19 1(c)(9) changes in the traffic and parking regulations  
20 where such changes do not establish a higher speed  
21 limit or result in more than a negligible increase in the  
22 use of the street.




