3 **Ordinance amending the San Francisco Administrative Code, Chapter 10, by amending**  
4 **Section 10.100-23 to change the gift fund category for the Animal Care and Control**  
5 **Welfare Fund, and to authorize the Department of Animal Care and Control to accept**  
6 **gifts of cash, equipment, property, and services not to exceed \$50,000.**

10 Be it ordained by the People of the City and County of San Francisco:

11 Section 1. The San Francisco Administrative Code is hereby amended by amending  
12 Section 10.100-23, to read as follows:

13 SEC. 10.100-23. ANIMAL CARE AND CONTROL WELFARE FUND.


14 (a) Establishment of Fund. The Animal Care and Control Welfare Fund is established  
15 as a category four fund to receive all fees ~~and donations of money which~~ that may be collected  
16 by the Animal Care and Control Department for the ~~adoption sale~~, redemption or surrender of  
17 ~~impounded~~ animals and for the care and feeding of animals by the Animal Care and Control  
18 Department thereof, and all fees collected by the Tax Collector for dog licenses, dog kennel  
19 licenses, cat registrations, and ~~business~~ licenses for businesses that maintain animals in the course  
20 of their business, including but not limited to businesses licensed under pursuant to the Business and  
21 Tax Regulations Code Sections 215, 220 and 221, 221.2 and 249.5 of Part III, San Francisco  
22 Municipal Code. The fund shall also be used as a gift fund to receive all donations of money that may  
23 be offered to the Animal Care and Control Department. The gift fund is designated as a category eight  
24 fund.

1 (b) Use of Fund. Said special fund shall be known and designated as the San  
2 Francisco Animal Control and Welfare Fund. The monies in this fund shall be expended solely  
3 for the purposes of defraying the cost of operating the Animal Care and Control Department  
4 exclusive of personnel costs.

5 (c) Equipment, Property and Services. Through the gift fund, the Department of Animal Care  
6 and Control is authorized to accept all gifts of money, equipment, property, supplies and services, not  
7 to exceed \$50,000 in value each gift, for the uses and purposes described in subsection (b).
