My name is Jennifer "JDub" Waggoner and I am speaking today on behalf of the League of Women Voters of San Francisco in SUPPORT of item #37 the resolution reaffirming Sanctuary.

Thank you to all for unanimously supporting this resolution.

San Francisco made a lot of cuts in the last budget cycle to close a significant deficit. Limiting entanglement with federal immigration enforcement conserves San Francisco's precious resources so that we fund what our City needs most. As a Sanctuary City, San Francisco doesn't spend money and staff time assisting federal immigration officials. That is a direct cost we avoid, freeing up money to use on San Francisco's priorities.

But the indirect costs of collaborating with federal immigration enforcement are just as important to consider.

Collaboration with ICE is associated with housing instability, chronic student absenteeism, low birth weight, negative child well-being, and decreased use of preventive and prenatal care for immigrant communities and their children. Collaboration with federal immigration enforcement makes us less trusting of institutions, like schools, hospitals, & first responders. San Francisco is healthier and more trusting thanks to Sanctuary. How much would the negative impacts of collaborating with ICE increase costs for San Francisco?

One final highlight: San Franciscans want to feel safe. Sanctuary makes us all safer. According to new research released in November 2024 by Eric Baumer of Pennsylvania State University and Min Xie of the University of Maryland, partnerships with ICE only increased risk for violent victimization, especially among Latinos. These same researchers found that Sanctuary policies did not correlate with higher levels of crime. Why would we collaborate with federal immigration enforcement to make San Franciscans less safe?

In closing: Sanctuary is a cost saving, data-driven policy that enhances public safety and community well-being for all
