6 WHEREAS, Alex Long has a long and dedicated history of volunteerism, community
7 activism, and public service; and

8 WHEREAS, Alex began volunteering with the Board of Supervisors' District 2 office in
9 early 2012, and since then could be found there almost every week; during that time, Alex has
10 been a vital part of the office's constituent services program; and

11 WHEREAS, Alex became an expert in the City's bureaucracy and has used those skills
12 to help constituents navigate government services; and

13 WHEREAS, Alex developed and implemented the office's constituent issues
14 management system, which allows volunteers and staff to document issues and track
15 responses from City departments quickly and efficiently, at no taxpayer expense; as the
16 system administrator, he tailored the software to fit the needs of the office, drastically
17 improving issue response time; and

18 WHEREAS, One of Alex's most lasting achievements is saving the 3 Jackson MUNI
19 bus line; when he learned about the proposal to eliminate the line, which serves many
20 seniors, he collected over 1,000 signatures to petition the Municipal Transportation Agency
21 and brought over 100 people to public comment in opposition of the change; and

22 WHEREAS, Alex has mentored countless new volunteers and interns; in addition to
23 sharing his immense depth of knowledge, he has gifted everyone with whom he has worked
24 with his graciousness, patience, and thoughtful sense of organization; and

1 WHEREAS, The residents of District 2 owe Alex a debt of gratitude for his years of
2 service to the community; now, therefore, be it

3 RESOLVED, That the San Francisco Board of Supervisors commends Alex Long for
4 his tireless commitment to District 2 residents through his service and advocacy; and, be it
