3 **Resolution appointing Deidre Von Rock, William Wong, and John Hentz, terms to be**
4 **determined, to the Citizen's General Obligation Bond Oversight Committee, residency**
5 **requirement waived.**

7 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
8 does hereby appoint the hereinafter designated persons to serve as members of the Citizen's
9 General Obligation Bond Oversight Committee, pursuant to the provisions of the San
10 Francisco Administrative Code, Article V, for the terms specified:

11 Deidre Von Rock, new position, seat 1, must be active in a business organization
12 representing the business community located within the City, for a new two-year term to be
13 determined;

14 William Wong (residency requirement waived), new position, seat 2, must be active in
15 labor organizations, for a new two-year term to be determined;

16 John Hentz, new position, seat 3, must be active in community organization, for a new
17 two-year term to be determined; and, be it

18 FURTHER RESOLVED, That the Board of Supervisors makes the following findings:

- 19 1. The membership of the Citizen's General Obligation Bond Oversight Committee has
20 a goal to be representative of the diversity of the City and County of San Francisco.
21 2. Applicant William Wong, new appointee, who is not resident of San Francisco, is a
22 person with experience that uniquely qualifies him/her to serve on the Citizen's
23 General Obligation Bond Oversight Committee.
24 3. The Citizen's General Obligation Bond Oversight Committee has attempted to fill
25 the position, for which William Wong was nominated, with an individual who is a

1 City resident and who has the specific experience, skills, and qualifications, but has
2 been unable to do so at this time. The Rules Committee has certified that William
3 Wong is qualified to serve on the Citizen's General Obligation Bond Oversight
4 Committee.

- 5 4. After exercising due diligence, the Board of Supervisors concludes that there are no
6 other possible representative, who are a resident of San Francisco and who have
7 the specific experience, skills, or qualifications possessed by these applicants, and
8 who are willing to serve on the Citizen's General Obligation Bond Oversight
9 Committee at this time; and, be it

10 FURTHER RESOLVED, That the Board of Supervisors waives the residency
11 requirement for William Wong, as allowed in cases where no qualified City resident, willing to
12 serve, can be found, pursuant to Section 4.101 of the City Charter that requires person(s)
13 appointed to boards, commissions, and advisory bodies established by legislative act of the
14 Board of Supervisors to be resident(s) of the City and County of San Francisco.
