15 Effective the week of ~~January 12 February 2, 2003, the Board shall hold a regular meeting in the~~  
16 Chamber in City Hall each week at 2:00 p.m. on Tuesday, unless it is a holiday, in which case the  
17 meeting shall be held on the next regular business day. The Board shall not meet during the week  
18 after Thanksgiving, between December 24 and December 31, inclusive, nor on any Monday  
19 or Tuesday if the following day is a holiday, unless the Board, by majority vote, decides to hold  
20 a meeting at these times.


