

1 [Contract Amendment - Bridgestone Americas Tire Operations, LLC - \$11,750,000]

3 **Resolution authorizing the Office of Contract Administration to enter into the Sixth**
4 **Amendment between the City and County of San Francisco and Bridgestone**
5 **Americas Tire Operations, LLC, for the rental of bus tires, in which the amendment**
6 **shall increase the contract limit from \$9,950,000 to \$11,750,000, for a period to**
7 **commence upon Board approval through September 30, 2014.**

9 WHEREAS, The Office of Contract Administration, by competitive bidding,
10 selected and entered into an Agreement with Bridgestone Americas Tire Operations,
11 LLC, (Bridgestone) dated April 6, 2009, for the rental of bus tires and the provision of
12 associated tire services; and

13 WHEREAS, The original contract with Bridgestone Americas Tire Operations,
14 LLC, has a term of five years through March 31, 2014, with options to extend the term
15 through March 31, 2018, and an original contract limit of \$5,000,000; and

16 WHEREAS, The Director of the Office of Contract Administration and the
17 Purchaser approved the First Amendment to the contract on April 15, 2010, to increase
18 prices; and

19 WHEREAS, The Director of the Office of Contract Administration and the
20 Purchaser approved the Second Amendment to the contract on April 11, 2011, to
21 increase prices, to increase the contract limit from \$5,000,000 to \$8,500,000, and to
22 update standard contractual clauses; and

23 WHEREAS, The Director of the Office of Contract Administration and the
24 Purchaser approved the Third Amendment to the contract on April 12, 2012, to
25 increase prices, and to update standard contractual clauses; and

1 WHEREAS, The Director of the Office of Contract Administration and the
2 Purchaser approved the Fourth Amendment to the contract on December 4, 2012, to
3 increase the contract limit from \$8,500,000 to \$9,500,000, and to update standard
4 contractual clauses; and

5 WHEREAS, The Director of the Office of Contract Administration and the
6 Purchaser approved the Fifth Amendment to the contract on April 4, 2014, to extend
7 the contract by six months to September 30, 2014, to increase the contract limit from
8 \$9,500,000 to \$9,950,000, and to update the standard contractual clauses; and

9 WHEREAS, The Office of Contract Administration estimates that the money
10 projected to be spent with Bridgestone Americas Tire Operations, LLC, could reach the
11 contract's limit in the reasonably near future; and

12 WHEREAS, Charter Section 9.118(b), "Contract and Lease Limitations," requires
13 the Board of Supervisors to approve any contract estimated to exceed \$10 million in
14 expenditures or amendments exceeding \$500,000 to such contracts; now, therefore, be
15 it

16 RESOLVED, That the Board of Supervisors authorizes the Director of the Office
17 of Contract Administration and the Purchaser to enter into the Sixth Amendment to the
18 contract with Bridgestone Americas Tire Operations, LLC, in substantially the form
19 attached to increase the contract limit from \$9,950,000 to \$11,750,000; and, be it

20 FURTHER RESOLVED, That within thirty (30) days of the Sixth Amendment being
21 fully executed by all parties the Office of Contract Administration shall provide the final
22 Sixth Amendment to the Clerk of the Board for inclusion into the official file.
