8 WHEREAS, The Department of Animal Care and Control (Department) is the recipient
9 of a bequeathal of \$75,040.33 from the Estate of Mabel L. Schwartz; and

10 WHEREAS, The Department is committed to the delivery of effective, courteous, and
11 responsive animal care and control services to the residents of this community; and,

12 WHEREAS, The Department is responsible for San Francisco's stray, injured,
13 abandoned, neglected, and mistreated animals as well as for the enforcement of all State and
14 local animal control and welfare laws; and

15 WHEREAS, It is the policy of the State that no adoptable animal should be euthanized
16 if it can be adopted into a suitable home; and

17 WHEREAS, The City and County of San Francisco has established a Special Fund
18 known and designated as the San Francisco Animal Control and Welfare Fund (San
19 Francisco Administrative Code Sec. 10.100-23); now, therefore, be it

20 RESOLVED, That the Board of Supervisors of the City and County of San Francisco
21 authorizes the Department of Animal Care and Control to accept and expend funds, according
22 to the Animal Care and Control Welfare Fund (Administrative Code Sec. 10.100-23(b)), from
23 the Estate of Mabel L. Schwartz in the amount of \$75,040.33 to promote animal care and
24 welfare.


