2 AUTHORIZING THE CITY LIBRARIAN TO ACCEPT AND EXPEND A GIFT OF ROYALTIES
3 FOR SAN FRANCISCO PUBLIC LIBRARY FROM THE ESTATE OF VEE LAWNHURST
4 AND TO ENTER INTO A MEMBERSHIP AGREEMENT AND TO EXECUTE A DIGITAL
5 HOME RECORDING ("DART") ROYALTIES AUTHORIZATION WITH THE AMERICAN
6 SOCIETY OF COMPOSERS, AUTHORS & PUBLISHERS ("ASCAP").

8 WHEREAS, The San Francisco Public Library ("Library") is in need of funds; and,

9 WHEREAS, The late Vee Lawnhurst has most generously and graciously directed
10 that ASCAP distribute 66.66% of his royalties, the value of which cannot be accurately
11 predicted but which have been approximately \$1000.00 per year in the last few years, to
12 the Library; and,

13 WHEREAS, The Board of Directors of ASCAP have, accordingly, designated the
14 Library as successor to the membership of the late Vee Lawnhurst; and,

15 WHEREAS, In order for ASCAP to negotiate, receive and distribute digital audio
16 royalty payments made under the Audio Home Recording Act due the late Vee Lawnhurst,
17 the Library must enter into a membership agreement with ASCAP, a copy of which is on
18 file in the Office of the Clerk of the Board of Supervisors in File No. 98-1287; now, therefore,
19 be it

20 RESOLVED, That the Board of Supervisors authorizes City Librarian to accept and
21 expend a gift of royalties for San Francisco Public Library from the Estate of Vee
22 Lawnhurst; and be it






