3 **Resolution enacting and rescinding traffic regulations on various streets.**

5 RESOLVED, That, in accordance with the provisions of the California Vehicle Code  
6 and the San Francisco Traffic Code, the following regulations governing the movement of  
7 vehicles are hereby enacted or rescinded as designated below:

8 LEFT LANE MUST TURN LEFT - ESTABLISH

9 10th Street, southbound, at Division Street

10 LEFT LANE MUST TURN LEFT, EXCEPT MUNI - ESTABLISH

11 Northpoint Street, eastbound, at The Embarcadero

12 RIGHT LANE MUST TURN RIGHT - ESTABLISH

13 Circular Avenue, northbound, at Monterey Boulevard

14 STREET CLOSURE (NO PUBLIC ACCESS) - ESTABLISH

15 Brazil Street, from Mansell Street to approximately 900 feet northerly (900-foot zone)

16 TOW-AWAY, NO STOPPING ANYTIME - ESTABLISH

17 Lincoln Way, south side, from 3rd Avenue to 31 feet easterly (31-foot zone)

18 Lincoln Way, south side, from 4th Avenue to a point 100 feet west of 3rd Avenue

19 TWO LEFT LANES MUST TURN LEFT - ESTABLISH

20 Lincoln Way, eastbound, at 3rd Avenue/Kezar Drive

21 NO RIGHT TURN - ESTABLISH

22 Lincoln Way, eastbound, at 3rd Avenue

Lincoln Way, eastbound, at 3rd Avenue




