

MOHCD's Mission

MOHCD's mission is to support San Franciscans with affordable housing opportunities and essential services to build strong communities.

- ❖ **Create:** 100% Affordable Housing, Mixed Income Housing, Transformed Communities, Affordable Home Ownership
- ❖ **Preserve:** Former Public Housing, Vulnerable Communities, Existing Affordable Homes
- ❖ **Protect:** Vulnerable Residents
- ❖ **Empower:** Communities + Neighborhoods, People Seeking Housing





MOHCD's Housing Programs

- ❖ **Production**
 - 100% Affordable Housing
 - BMR Inclusionary Program – rentals and ownership
- ❖ **Preservation**
 - Small and large site acquisition
 - RAD and HOPE SF
 - Sites with expiring affordability restrictions
- ❖ **Homeownership**
 - BMR Inclusionary Housing Program
 - Downpayment Assistance and Teacher Next Door

Existing Affordable Housing

- ❖ 691 developments with 26,375 units of affordable rental and ownership housing
- ❖ Produced and preserved 7,832 affordable homes between 2014-2018, on track to achieve 10,000 units by 2020

Affordable Housing Pipeline

- ❖ 68 developments between MOHCD and OCII (former Redevelopment Agency) = 5,368 units
 - 3,320 units of Family housing
 - 628 units of Senior housing
 - 1,166 units of Supportive Housing for Homeless, plus 213 units of TAY housing

Senior Housing

- ❖ 4,781 dedicated senior units, of which 349 units for formerly homeless seniors
- ❖ 9,943 units occupied by seniors
- ❖ Pipeline: 95 Laguna (79 units); 735 Davis (52 units), 1296 Shotwell (94 units), Casa de la Mision (35 units), 1064 Mission (103 units), Transbay Block 2 East (169 units), 967 Mission (96 units)
- ❖ Preserved 2,192 units of seniors and disabled housing through RAD

Disabled Housing

- ❖ 10% of new construction units meet ADA accessibility requirements
- ❖ 1,935 dedicated disability units
- ❖ 5,523 units occupied by people with a disability
 - Physical/Mobility = 1,497
 - Mental/Developmental = 887
 - Hearing/Visual = 135
 - More than one disability = 614
 - Other = 239
- ❖ Pipeline: Eddy & Taylor (5 units)

Veterans Housing

- ❖ 2 buildings with 171 units for veterans
- ❖ Pipeline: 104 units Maceo May, 62 units at Edwin M. Lee Apartments

Preservation

- ❖ Small and Large Sites Acquisition
 - 28 buildings with 205 units converted to permanent affordability
 - Pipeline: 13 buildings with 133 units
- ❖ Public Housing
 - HOPE SF
 - 535 public housing replacement units complete or under construction (0-60% AMI)
 - 212 new affordable units complete or under construction (0-60% AMI)
 - RAD: 3,480 units of existing housing rehabilitated (0-60% AMI)

Anti-Displacement

❖ Tenant Right to Counsel

- \$5.8 million for FY 18-20 for full implementation
- Since July 1st, 805 total full-scope cases reported
- 334 cases closed, of which 242 or 73% resulted in the household staying in their home (ie evictions defeated)

❖ Tenant Rental Assistance

- 374 households received back-rent assistance in order to avoid eviction
- 42 households received move-in assistance in order to move into more stable housing

Anti-Displacement

❖ Housing Preferences in FY16-18

- 69 households took occupancy in new affordable housing using Displaced Tenant Housing Preference
- 188 households took occupancy in new affordable housing using Neighborhood Preference

❖ Homeowner Stabilization Efforts in FY16-18

- 28 low-income owners averted foreclosure and preserved their home through MOHCD Home Preservation Programs

Workforce/Middle-Income Housing

❖ Production Pipeline:

- 88 Broadway: 21 units will serve up to 100-120% AMI
- Francis Scott Key: 80 units will serve SFUSD educators up to 130% AMI

❖ Preservation

- Small and large sites: 205 units with households up to 120% AMI
- South Beach Marina Apartments: 101 units with households up to 120% AMI
- Bayside Village: 172 units with households up to 120% AMI

❖ Homeownership Assistance in FY17-18

- 42 new BMR/OCH ownership units for households up to 120% AMI
- 50 down payment assistance loans for households up to 175% AMI
- 23 SF educator households purchased housing
- Resold 49 BMR ownership units

❖ City Inclusionary Program

- Rentals will serve up to 130% AMI and ownership units up to 150% AMI
