1 [AIRPORT ADMINISTRATION]  
2 RETROACTIVELY,  
3 APPROVING THE CONTROLLER'S CERTIFICATION THAT PARKING  
4 MANAGEMENT SERVICES FOR SAN FRANCISCO INTERNATIONAL  
5 AIRPORT CAN PRACTICALLY BE PERFORMED BY PRIVATE  
6 CONTRACTOR AT A LOWER COST FOR THE YEAR COMMENCING JULY 1,  
7 1999 THAN IF WORK WERE PERFORMED BY CITY EMPLOYEES AT  
8 BUDGETED LEVELS.

9 **WHEREAS**, the electorate of the City and County of San Francisco passed  
10 Proposition J in November 1976, adding Section 10.104.15 to the charter allowing City  
11 Departments to contract with private companies for specific services which can be  
12 practically performed for a lower cost than similar work by City and County  
13 employees; and,

14 **WHEREAS**, the controller has certified on November 17, 1999 that the services  
15 involved in the management and operation of employee parking facilities at San  
16 Francisco International Airport for the year commencing July 1, 1999 can be performed  
17 by the contractor at a lower cost to the City and County of San Francisco than if such  
18 services were performed by employees of the City and County of San Francisco;  
19 now, therefore, be it

21 **RESOLVED**, that pursuant to Section 10.104.15 of the Charter, this Board of  
22 retroactively,  
23 Supervisors hereby approves/said Controller's certification.


