3 **Ordinance authorizing settlement of the lawsuit filed by San Francisco Motorcycle Club**
4 **against the City and County of San Francisco for \$140,000; the lawsuit was filed on**
5 **August 20, 2015, in San Francisco Superior Court, Case No. CGC-15-547492; entitled**
6 **David Alfaro, et al. v. City and County of San Francisco; the lawsuit involves inverse**
7 **condemnation arising out of flooding damage during major rainstorms; as it relates**
8 **only to property loss of plaintiff San Francisco Motorcycle Club, by the payment**
9 **of \$140,000, and excluding the claim by this plaintiff for diminution of value for**
10 **plaintiff's real property and the claim by plaintiff for attorney's fees, costs and interest,**
11 **which will be addressed in later proceedings.**

12 Be it ordained by the People of the City and County of San Francisco:

13 Section 1. Pursuant to Charter Section 6.102(5), the Board of Supervisors hereby
14 authorizes the City Attorney to settle the action entitled David Alfaro, et al. v. City and County
15 of San Francisco, San Francisco Superior Court, Case No. CGC-15-547492 by the payment
16 of \$140,000. The lawsuit involves inverse condemnation arising out of flooding damage
17 during major rainstorms.

18 Section 2. The above-named action was filed in San Francisco Superior Court on
19 August 20, 2015. This is an action brought by owners or occupants of several dozen
20 properties located in San Francisco against defendant City and County of San Francisco.

21 Section 3. This is a partial settlement of the action. It resolves the personal and real
22 property of plaintiff San Francisco Motorcycle Club of the claims. The parties will
23 subsequently and separately address the personal and real property claims of other plaintiffs
24 to the action, all claims of diminution of property value, and all claims for statutory attorney's
25 fees.


